


Denton Merrill Garner



independently from the Texas Health and Human Services Department, which oversees these facilities. She and others are also urging more volunteers to advocate for residents as well as more state funding to hire additional ombudsman.

"We would be lost in the long-term care community without them (volunteers), but they definitely need more support across the board," said Andrea Earl, the associate state director of advocacy and research for the AARP.

In 2024, the state ombudsman had its highest turnover rate at 255. Ducayet said ideally the state would have one staff member for every 2,000 licensed care facility beds. Right now, the ratio is one person for every 2,514 beds, which would require hiring 22 more full-time employees as well as increasing the volunteer base.

Wastewater leaks from oil wells pose danger

The water that comes up as a byproduct of oil and gas fracking is becoming a bigger headache for the state's energy operators and those who regulate them, the Houston Chronicle reported. Most of the "produced" water is injected into disposal wells that carry it into geologic formations for containment.

The extremely salty water nine time saltier than the ocean – also contains a number of carcinogenic chemicals, such as benzene. The practice of wastewater injection is believed to have caused earthquakes across the state and several environmentally damaging and costly blowouts.

One barrel of Permian crude can also produce as many as eight barrels of tainted water. The industry is working to create a new technology to desalinate the water so it doesn't have to be

Texas now home to more than 31 million

The Lone Star State added nearly 563,000 residents in the last year, according to the U.S. Census Bureau. The Tribune reported the state's growth has slowed, though the 1.8 percent growth rate is still the third highest in the country, behind Florida and the District of Columbia.

Christmas is over, but that doesn't mean scammers have taken a holiday. Officials with the U.S. Postal Service are warning about a scam being sent by text messages, The Dallas Morning News reported.

"Spell Check" - first thought to be a handy computer feature to help us use the correct letters in the proper order for word formation--often goes haywire.

Like oft-discussed Artificial Intelligence (AI is the abbreviation, despite my thinking it to be short for "Alfred" in the early going), it can be dead wrong, redden faces and run far afield from what is intended.

This may be true when the name of our current hometown--Burleson, TX, where we have domiciled in semi-retirement since 2002—is typed.

Burleson had hardly gotten the "sleepy" rubbed from its eyes when we moved into our modest tract home on a cul-de-sac near Interstate Highway 35W. Longtime residents at the time bragged about the community's immense growth, its population

the turn of the century.

Old-timers rattled on about memories of one traffic light, a couple of eating places and it being the "crepe myrtle capital" of Texas. Many comments seemed trivial, usually trailing off to other topics like grandchildren and the weather. (Similarly, Brownwood, TX, where I grew up, once was known as "the feather duster capital of the world," to which millions of deceased turkeys might attest.)

Over the past two decades, there've though, been interesting-or at least, semiinteresting-facts surfacing long enough to pique interest about Burleson, now wide awake.

Interestingly (and most sentences beginning with this word aren't), our town is named for a university president, Dr. Rufus Columbus Burleson.

Not only was the late educator a president, he took on the task twice - 25 years apart at Baylor University, which was chartered by the State of Texas in 1845. (BU almost moved to Dallas in 1929, but in that initial year of the Great Depression, most everything huddled in place.)

That a man would serve in this role for a decade (1851-1861)

reaching 20,000 shortly before and be asked to return in 1886 for 11 more years defies both probability and imagination.

I have digressed shamelessly. Research entices with "rabbit trails," many of which I traverse gleefully. Initially, I was addressing spell check. But wait. There is a connection. Often when I type the word "Burleson," spell check suggests that my intent might have been to type "burlesque." It even offers to make the correction for me with the click of a key. Burleson was a good ten miles from any known sin at the time of its founding in 1912.

Fact is, there were only a few hundred people to sin and/or walk the straight and narrow at the time. Humbly begun, Burleson was but a stop on the Interurban (tram-like electrical rail cars) that ran 10 times daily between Fort Worth and Cleburne.

Henry Renfro, a visionary who owned much land and cut a wide swath politically, wanted to honor the man who had been his teacher, then president, at Baylor. Thus Burleson was born, even if spell check doesn't cotton to the choice.

We'll never know for sure, of course, whether Dr. Burleson cared to have his name on a city limits sign. He might have wished his middle name-Columbushad been chosen. But, another community had chosen that historic name a half-century earlier. "Rufus" doesn't set well, either. Neither do "Rufusville," "Rufusburg" or perhaps "Crepe Myrtleville". We can only guess how spell check might have mangled these.

Burleson has grown threefold, now around 60,000, since our arrival, with no end in sight. (Proximity to FortWorth-now ahead of Austin as Texas' fourthlargest city—helps.)

Our family name identifies buildings at Howard Payne University in Brownwood, TX, where I graduated in 1961 and served as president, 1986-1997.

A couple of dozen students gathered for the naming of Newbury Place Apartments, claiming it to be an historic day. "Now they'll know where to deliver the pizza," one student bragged, seemingly relieved.

Have books, will travel

Aledo resident bringing reading to others

For Aledo resident Savannah Lacefield, May Flowers Mobile Bookstore is a labor of love.

Lacefield, 25, opened the store about a year ago, and to this point has had a phenomenal reception.

"The response from the community has been overwhelmingly positive," Lacefield said. "People were thrilled to have an in-person location to shop for books.. It's also a unique concept, so people are interested to come into the trailer and see what it is and what's inside. Getting connected to the community is one of the best parts of the job."

The idea for the store came about during a late-night brainstorming session Lacefield had with her husband, Riley.

"I had a dream of opening a bookstore, but wasn't prepared for a brick and mortar," Lacefield said. "My husband mentioned that he had a cargo trailer he didn't use and the next day we started clearing it out to turn into a bookstore on wheels. It was the perfect solution to make my dream a reality."

Then they went to work on renovations.

On the road

Lacefield brings the store to various events around Parker County with the help of some fairly sophisticated engineering.

"My husband helps me haul it to and from events," Lacefield said. "The books are transported on the shelves and I use small tension rods on each shelf to keep them from falling off during travel. Riley sets the trailer up and I unload the inside and make the shelves look like a bookstore."

The biggest difficulty for Lacefield is winter, when operations slow down quite a bit.

"The challenge with having an outside business is that you heavily rely on good weather and outdoor events and markets," Lacefield said. "Winters in Texas are not fun, so there are very few outdoor markets after the holiday season. Things tend to pick back up starting in March when it warms up, but Spring brings rain showers which are a challenge too. Weather is definitely May Flowers' biggest challenge."

While the mobile bookstore draws customers from all over, it is mainly people from Parker County who shop at May Flowers.

"This is largely because I prefer to stay plugged into the community and only do events in Parker County," Lacefield said. "I will get people from outside of Parker County when I set up at Weatherford First Monday Trade Days or Weatherford's Second Saturday Market."

Launching at home

The Aledo bookstore owner said one of her favorite memories was launching at Christmas Tyme in Aledo in 2023.

"I grew up in Aledo and grew up going to Christmas Tyme in Aledo, so it was special for me to get to launch my own small business in my hometown," Lacefield said. "It was also an 'I did it!" moment because the response and excitement were overwhelming. I felt like I had accomplished my dream and was beyond proud of the hard work that I and everyone who helped me put into it."

What stands out to her the most, however, was an episode from a summer series Lacefield did called Popsicles In The Park.

"Every Wednesday over the summer, I set up at Gene Voyles Park in Hudson Oaks and hosted a free story time," Lacefield said. "We would read a few books, sing and dance a few songs, and then at the end everyone got a Popsicle. These events weren't about profit or having somewhere to set up the trailer – sometimes I didn't even bring it. They were about engaging with kids in the community and getting them excited about reading. It was also an opportunity for parents to get their kids out of the house for an hour. I loved interacting with each kid and having them come back each week so excited and ready for a story and a Popsicle."

TOWN OF ANNETTA NORTH ORDINANCE NO. 2024-04

AN ORDINANCE OF THE TOWN OF ANNETTA NORTH, TEXAS **REGULATING THE INSTALLATION, REPAIR AND MAINTENANCE** OF UTILITY AND TELECOMMUNICATIONS FACILITIES WITHIN THE PUBLIC RIGHTS-OF-WAY IN THE TOWN OF ANNETTA NORTH, **TEXAS; REQUIRING REGISTRATION AND A CONSTRUCTION PERMIT; PROVIDING FOR REVOCATION AND APPEAL PROCEDURES; PROVIDING CONSTRUCTION REQUIREMENTS; PROVIDING FOR THE** FILING OF RECORD DRAWINGS; PROVIDING FOR RESTORATION OF THE PUBLIC RIGHTS-OF-WAY; PROVIDING A PENALTY; PROVIDING A CUMULATIVE CLAUSE; PROVIDING A SEVERABILITY CLAUSE; **PROVIDING A SAVINGS CLAUSE; PROVIDING FOR PUBLICATION;** AND PROVIDING AN EFFECTIVE DATE.

SECTION 24. **ENFORCEMENT AND PENALTY.**

- (A) A Person commits an offense if, in connection with the performance of Construction in the Right-of-Way, the Person:
- (1) performs, authorizes, directs, or supervises Construction without a valid Construction Permit;
- (2) violates any other provision of this Ordinance;
- (3) fails to comply with restrictions or requirements of a Construction Permit issued under this Ordinance;
- (4) fails to comply with an order or regulation of the Town issued pursuant to this Ordinance;
- (5) damages the public Right-of-Way beyond what is incidental or necessary to the performance of the Construction;
- (6) damages public or private Facilities within the public Right-of-Way; or
- (7) fails to clear debris associated with the Construction from a public Right-of-Way after Construction is completed.
- (B) It is a defense to prosecution under subsection (A)(6) if the Person complied with all of the requirements of this chapter and state law and caused the damage because the Facilities in question:
- (1) were not shown or indicated in a plan document, plan of record, record construction drawing, or field survey, staking, or marking; and
- (2) could not otherwise be discovered in the public Right-of-Way through the use of due diligence.
- (C) A culpable mental state is not required to prove an offense under this chapter. A Person who violates a provision of this chapter is guilty of a separate offense for each day or portion of a day during which the violation is committed, continued, authorized, directed, or permitted. An offense under subsection (A)(7) is punishable by a fine of not less than Five Hundred (\$500.00) or more than Two Thousand (\$2,000.00). Any other offense under this ordinance is punishable by a fine of Five Hundred (\$500.00). Each day that a violation is permitted to exist shall constitute a separate offense.

FEBRUARY 2

The Aledo City Council granted a license for a local business to sell guns at its location.

The Hudson Oaks City Council approved changes to the city's commercial sewer rate calculation at its Jan. 24 meeting.. In addition, Also at the meeting, Oncor Area Manager Michael Dimas provided members with an update on a new energy substation – called Bell Mountain - that is expected to be online by May. Once it's switched on, it will alleviate the load on current substations and provide 85 percent of the energy needed to area residents.

The Weatherford City Council approved a Chapter 380 Economic Development Agreement with Costco. Such agreements enable cities to provide incentives encouraging developers to build in their jurisdictions and typically take the form of property tax abatements, loans or grants, commitments for infrastructure, or payments of portions of the sales tax generated by the project. The new Costco will be 160,000 square feet in size and construction began later in the year.

Two leaders from Parker County were among the honorees at HerStory 2024, an event sponsored by the Outlook Positive Express Network, an affiliate of the American Business Women's Association, on Feb. 3 in Dallas. Kit Marshall and Zan Prince of Parker County were among five honorees at the event, where the keynote speaker wase Fort Worth native and community/ civil rights activist Opal Lee, a lifetime achievement award recipient.

For the first time since 2016, Weatherford ISD conducted a Comprehensive Financial Audit with the help of Snow Garrett Williams and were presented with the results at its Jan. 22 meeting. Kathy Williams, Certified Public Accountant and partner at SGW, provided a synopsis of the findings and gave trustees the overall "seal of approval.

Bearcat football players, fans, families, and the community celebrated the team's 12th state championship at Aledo High School.

A "laid back man-magnet" barber shop called the Bearded Beast opened in Aledo.

In girls basketball, Brewer defeated the Aledo Ladycats to stay atop district. Brewer also defeated the Bearcats. Both soccer teams lost to Justin with district now under way.

Led by gold medal performances from Haley Roberson and Porter Lane, Aledo fielded a solid contingent at the district swim meet to represent the program in the upcoming Class 5A Region II Meet in Mansfield Feb. 9-10.


Lady Roos win own tourney

When reviewing the nominations, the THSCA considers each student's GPA, class rank, SAT and/ or ACT score. The students receive points based on each criteria. The total number of points they receive determines which team they are placed on. The best team a player can make is the elite team, which requires a near perfect score in all categories. After elite, players are placed on first, second and honorable mention teams.

Three area athletes earned elite status: Aledo football player Cole Crawford, Weatherford football player, and Weatherford cross country runner Tate Nobis.

The program with the most honorees is Aledo football, which

had 14 players receive accolades. Honorable mention Weatherford team tennis had eight players awarded and Aledo volleyball had seven.



Hejny transferring to **Oklahoma State, reports say**

Exiting TCU after one season

The Cowboys are getting a new quarterback, reports all over the internet are saying.

Not THOSE Cowboys.

The Oklahoma State Cowboys.

Former Aledo Bearcats all-state quarterback Hauss Hejny, who announced in mid-December that he was leaving TCU and entering the transfer portal, is apparently going to land at Oklahoma State. Hejny himself even reposted several posts on X (formerly Twitter) related to the subject, including one from OrangeVZN that said simply "Welcome to it @ HaussHejny#GoPokes."

Efforts to reach Hejny himself were not returned.

Hejny saw limited action for the Horned Frogs (9-4) this season, playing in four games and redshirting. He didn't throw any passes, but rushed 15 times for 65 yards.

At TCU Hejny, a true freshman, was playing behind sophomore quarterback Josh Hoover, who set a Horned Frogs single season passing record in 2024 with 3,949 yards. Hoover also led the Horned Frogs to a 34-3 win over Louisiana in the New Mexico Bowl.

Hejny chose TCU out of high school to follow in the footsteps of his parents, who were both athletes at the school. His father played as a defensive lineman in the early 2000s and his mother played basketball.

Hejny's transfer to Oklahoma State comes alongside the Cowboys' hiring of Doug Meacham as offensive coordinator. Meacham was inside receivers coach at TCU last season.

Hejny is expected to battle for the starting job in Stillwater against another redshirt freshman Zane Flores, redshirt sophomore Garrett Rangel from Frisco, and true freshman Maealiuaki Smith.

The Cowboys are coming off a 3-9 season in which they were 0-9 in the Big 12 Conference, which TCU also plays in. It ended a streak of 18 consecutive winning seasons under head coach Mike Gundy.

At Aledo, Hejny led the Bearcats to a 30-2 record in his two seasons as the starting quarterback, including a 30-game winning streak, the second longest in school history. He was also named the MVP of the 2022 Class 5A Division I state championship game.

Coming out of high school, Hejny was listed as one of the top 12 prep quarterbacks in the nation.

Hejny is a dual threat. For the Bearcats he passed for more than 5,000 yards and 50 touchdowns, along with rushing for almost 2,500 yards and 29 more TD. He even caught 26 passes for 648 yards and seven touchdowns as a sophomore before moving to quarterback as a junior.
