## Marijuana growth operation destroyed

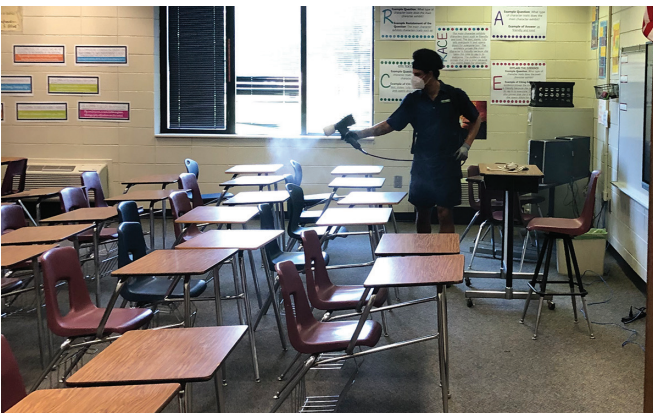
Swainsboro Police Department's drug suppression unit recently concluded a criminal investigation into information regarding a marijuana field located on Kemp Road. Information discovered led to an operational plan executed by officers and county deputies to locate and remove any marijuana plants found under the execution of a search warrant requested by SPD drug unit. On the evening of July 9 at approximately 7:45 p.m., law enforcement officials located a marijuana grow operation as noted by the investigation just off Kemp Road. On that day, a total of 19 mature plants were removed. The following day, officers and

deputies conducted a second search of the area. To better search the area, a helicopter was used to scan the property. A second field was discovered and ground units were called in to confiscate an additional 17 mature plants that were discovered neatly planted between pine trees. The investigation concluded with the removal of 36 mature plants being removed from the property and the arrest of one white male subject, William Michael Goddard, of 115 McMillian Drive in Swainsboro. The case remains under investigation as information relating to additional individuals involved may lead to more arrests by drug unit.

## Emanuel County Schools using newest technologies to ensure buildings are protected against viruses

As of last week, all facilities of the Emanuel County School System have begun being treated by the Ecovasive application team to ensure they are properly disinfected for the start of the 2020-2021 school year. Classes are slated to begin as scheduled on August 3 in the K-12 district of approximately 4,500 students and 300 faculty members. 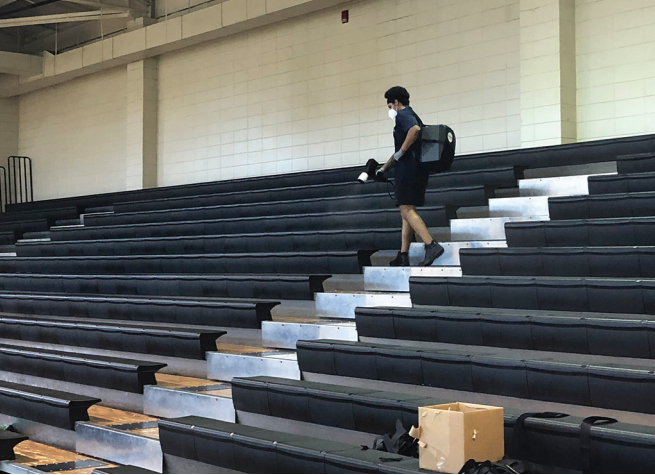



# BOE announces reopening plan for upcoming school year

The Board of Education convened Tuesday, July 14, at 5:30 p.m. at the Swainsboro Middle School for its regularly scheduled meeting. Chairman Mason Henry called the meeting to order and Reverend David Uncles, pastor of First Methodist Church, led the invocation prior to the pledge of allegiance being recited by all.

Board members reviewed the consent agenda, which consisted of minutes from the June 9, 2020 board meeting, financial reports, and FY 20-21 transpiration fuel bids for diesel, gasoline and oil).

In reference to superintendent comments:• Superintendent Dr. Kevin Judy gave an update on SHS renovations and advised that the process is running as scheduled. He also stated that roofing projects for SES and ECI are now complete and finalizing punch list. The roofing project for SPS had also began.

• Graduation plans for ECI were announced to be held at 7:30 p.m. Friday, July 24. SHS will host graduation services the following morning on Saturday, July 25, at 9 a.m. Both graduation ceremonies will take place at their school's football stadium. Social distancing will be practiced for all family units.

**Dr. Judy then presented Emanuel County Schools reopening plan located below.**

Guidelines for Opening Schools on August 3, 2020 Emanuel County Schools has adopted the following guidelines to reopen our schools based on the latest CDC, Georgia Department of Public Health, and the Georgia Department of Education recommendations:

• All students and employees must stay home if they have COVID-19 symptoms, tested positive for COVID-19, or had close contact with a person with COVID-19 within a 14-day window. Employees and parents/guardians are asked to self-report to the school nurse. A written physician's release will be required for return. Quarantined students will have access to their education through a variety of methods.

• Temperature checks will be required of all personnel and students before

entering the school environment. Students and employees with COVID-19 symptoms or a temperature of 100 and above will be immediately isolated, required to wear a mask, and sent home. Local health officials will be notified immediately for guidance on the next steps.

• Employees are encouraged to wear masks when social distancing is not possible - for example, helping a student with an assignment at their desk. Students are not required - but are encouraged - to wear a mask, especially in common areas such as hallways and bathrooms. Counselors and administrators will support mask-wearing efforts at each school. Students who ride school buses are required to wear masks. The school nor district will provide mask.

• The school nurse will be the school's main COVID-19 point of contact.

• Frequent hand washing breaks will take place daily in all elementary schools, where students will be required to wash their hands for a minimum of 20 seconds. Middle and high school students and employees will be reminded to wash their hands throughout the day for the same length of time.

• All will be reminded to cover coughs and sneezes with a tissue, place the tissue in the trash, and immediately wash their hands.

• Hand sanitizer stations will be located throughout each building. Locations include hallways, lunchroom, media center, office areas, etc. Students and staff are also encouraged to bring hand sanitizer from home.

• To promote COVID-19 protective measures, signs will be posted in highly visible locations, and schools will broadcast daily messages. 2 • Schools and departments will develop a schedule for increased cleaning and disinfection. The custodial staff has been trained on the safe and correct application of all disinfectants. Frequently touched surfaces will be cleaned and disinfected throughout the day (door handles, sink handles, light switches, etc.).

• Ventilation systems will be monitored regularly

to ensure proper operation and increased circulation of outdoor air as much as possible.

• Based upon classroom configuration and to the extent possible, student desks will face in the same direction, and students seated at tables will sit on the same side. Excess furniture will be removed from classrooms to allow teachers more room to separate students.

• The sharing of items that are difficult to clean or disinfect will be discouraged.

• Schools will promote social distancing when feasible and consider practices for transitioning, such as lanes for travel, throughout the school. Additional time for transitions, designate flow paths to minimize student congregation, stagger class movement to reduce the number of students in a hallway at the same time is just a few of these measures.

• Non-essential student movement throughout the school day will be limited.

• Outdoor recess will be continued, but the number of students gathered in one area will be limited. Some playground equipment that cannot be sanitized may be prohibited for student use.

• While ensuring the safety of children, to the extent possible, students will eat in classrooms, lunchrooms, and outside. This will allow students to be spread out during their lunchtime.

• Traditional water fountains will be closed; water fill stations will be open. Students and staff are encouraged to bring plastic water bottles from home (no carbonated or sugar drinks allowed).

• In place of field trips, assemblies, special performances, and school-wide meetings or events, including open house and curriculum nights, virtual activities will be pursued.

• No parent walk-up for dismissal. All afternoon car dismissals must stay in the car line.

• Non-essential visitors, volunteers, and activities involving external groups or organizations will be limited.

• Parent/guardian teacher conferences will be held virtually, when possible. 3

- Transportation of Students on Buses:
  - o We encourage all parents that can trans-

port their children to and from school to please do so. This will minimize the number of riders we have on a bus route.

- o Students are re-
- quired to wear a mask while riding the bus.

Students will not be allowed on the school bus without a mask covering their nose and mouth. The school nor district will provide mask.

- o Students will be asked to keep their

hands to themselves and face forward throughout the trip to school and home. Parents need to encourage this of their children.

- o All buses will be deep cleaned before the school year starts.
- o Every bus will be equipped with disinfectant and will be disinfected after each route.
- o Each bus will have hand sanitizer stations located at the entrance for students to use as they enter and leave the bus.
- o Although many buses have air conditioning, drivers will partially open select windows of all buses to allow free flow of fresh air.

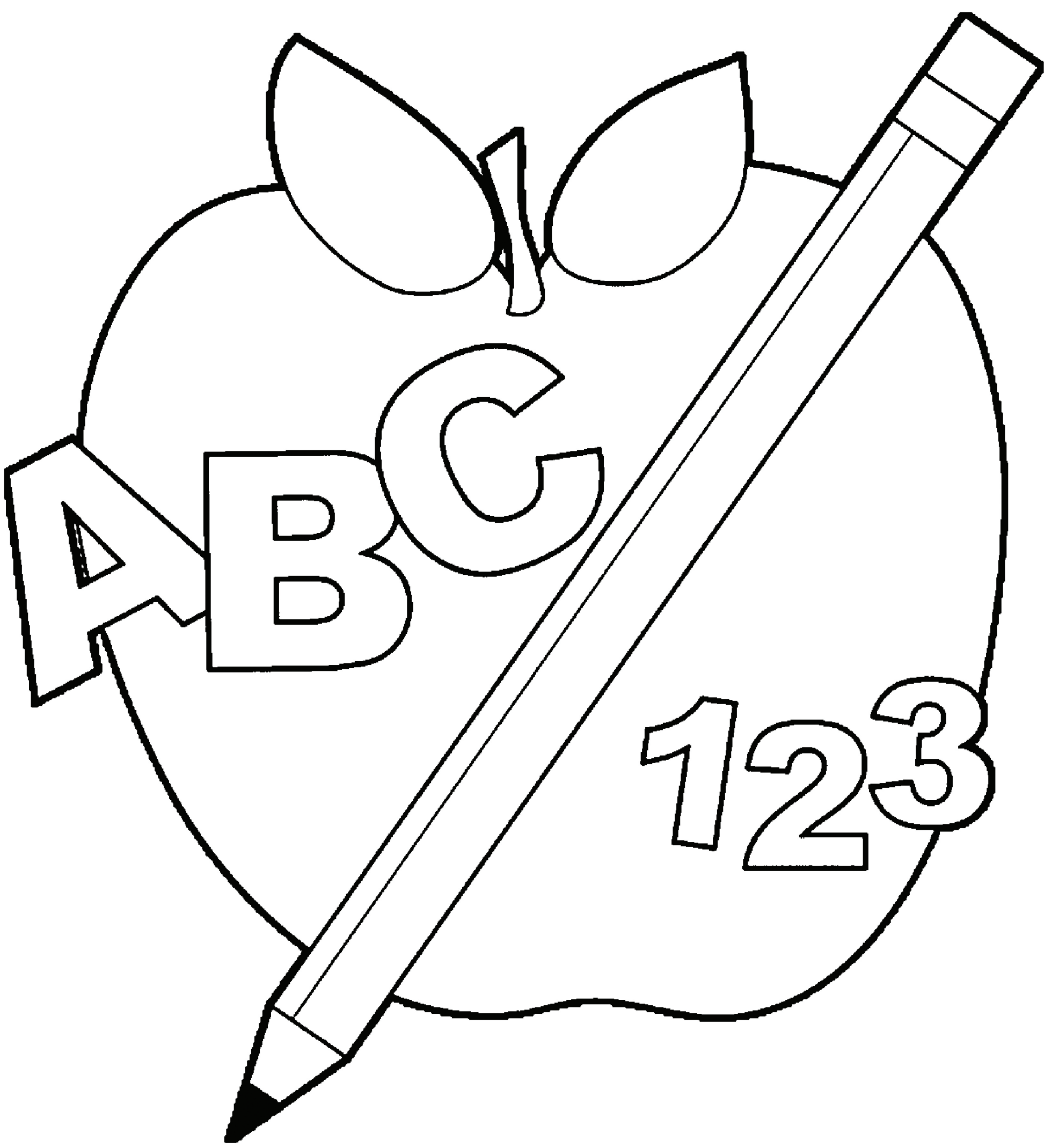



Dear Savvy Senior,  
What happens to a person's possessions if they die without a will? I'm almost 60 years old and have never gotten around to making one, but the coronavirus crisis has made it a priority.  
Will-less Willie

Dear Willie,  
The coronavirus crisis has lit a fire under many Americans when it comes to getting their affairs in order. Currently, fewer than half of American adults have prepared a will or living trust. If you die without a will, the state you reside in will determine what happens to your assets. Every state has intestacy laws in place that parcel out property and assets to a deceased person's closest living relatives when there's no will or trust in place. But these laws vary from state-to-state.

Here is a general breakdown of what can happen to a person's assets, depending on whom they leave behind.

**Married with children:** When a married person with children dies without a will, all property, investments and financial accounts that are "jointly owned" automatically goes to the surviving co-owner without going through probate, which is the legal process that distributes a deceased person's assets.

But for all other separately owned property or individual financial accounts, the laws of most states award one-third to one-half to the surviving spouse, while the rest goes to the children.

**Married with no children or grandchildren:** Some states award the entire estate to the surviving spouse, or everything up to a certain amount (for example the first \$100,000). But many other states award only one-third to one-half of the decedent's separately owned assets to the surviving spouse, with the remainder generally going to the deceased person's parents, or if the parents are dead, to brothers and sisters.

Jointly owned property, investments, financial

accounts, or community property automatically goes to the surviving co-owner.

**Single with children:** All state laws provide that the entire estate goes to the children, in equal shares. If an adult child of the decedent has died, then that child's children (the decedent's grandchildren) split their parent's share.

**Single with no children or grandchildren:** In this situation, most state laws favor the deceased person's parents. If both parents are deceased, many states divide the property among the brothers and sisters, or if they are not living, their children (your nieces and nephews). If there are none of them, it goes to the next of kin, and if there is no living family, the state takes it.

**Make a Will**  
To ensure your assets go to those you want to receive them, you need to create a will or trust. If you have a simple estate and an uncomplicated family situation, there are do-it-yourself resources that can help you create all these documents for very little money.

Some top-rated options include the Quicken WillMaker & Trust 2020 downloadable software (available at *nolo.com*) that costs \$90 and works with Windows and Macs and is valid in every state except Louisiana; LegalZoom (*legalzoom.com*), which offers basic wills for \$89 or \$99 if you'd like assistance from an independent attorney; and Trust & Will (*trustandwill.com*) which charges \$89 for a basic will.

If, however, you want or need assistance or if you have a complicated financial situation, blended family or have considerable assets, you should hire an attorney. An experienced attorney can make sure you cover all your bases, which can help avoid family confusion and squabbles after you're gone.

Costs will vary depending on where you live, but you can expect to pay anywhere between \$200 and \$1,000 for a will.

The National Academy of Elder Law Attorneys (*naela.org*) and the American College of Trust and Estate Counsel (*actec.org*) websites are good resources that have directories to help you find someone in your area.

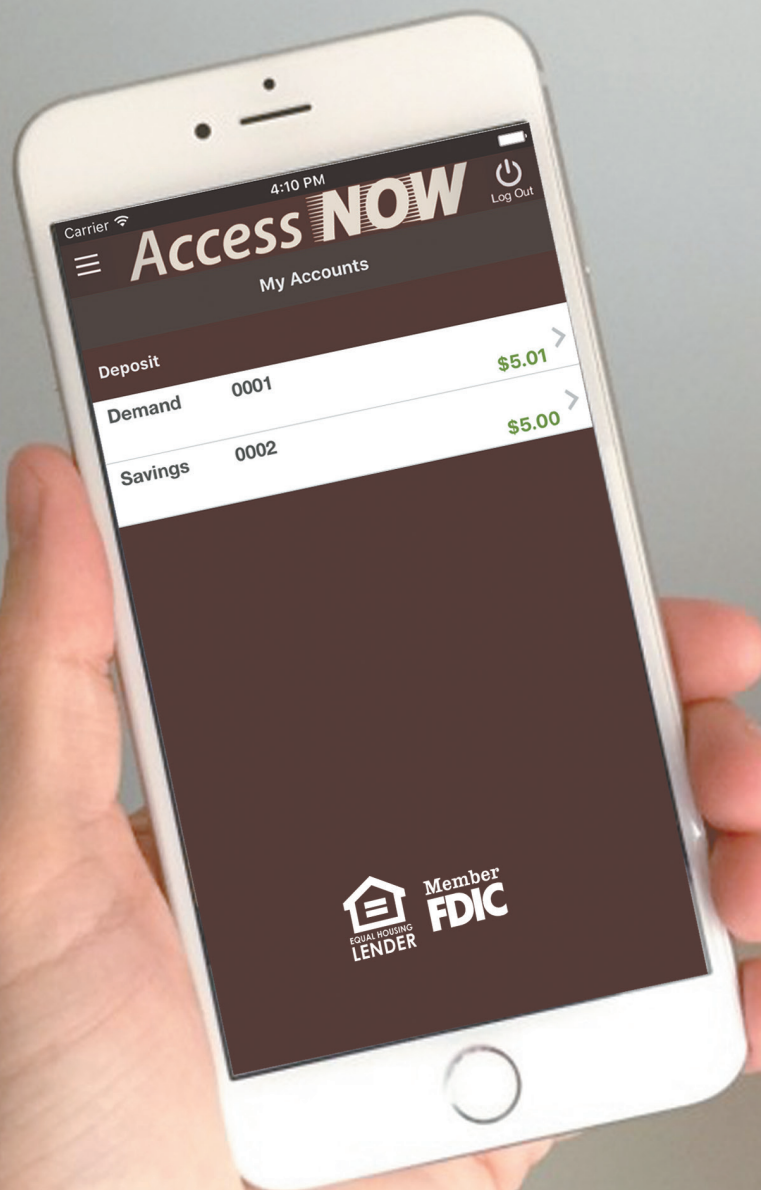

### Question: What is 3D printing?

Answer:  
During this pandemic, there has been more in the news about 3D printing from compa-

nies and colleges printing face shields to making parts for ventilators faster, etc. The question for many of you is what

is 3D printing that they are referencing. Normal printing as we have known since Guttenberg is where he

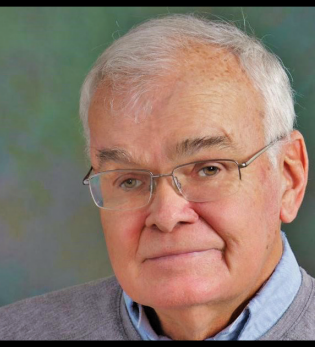
puts an image on a paper or some other object but it is 2D, it is just flat on paper and not something you can feel (braille crosses to a very limited 3D).

With 3D printers (which are really a lot more than printers in the traditional sense of word) you can create objects that we have used the term of printing them as it works similar to the traditional printing process. Instead of just one sweep across paper and flat it uses filament that is melted and placed on a surface and then keeps moving higher and distributing more melted filament.

With this approach you can literally manufacture parts using a program that has been made of how to print the part.

There are free plans for lots of items that you can get and run in a 3D printer and create. Old car encrustics will use 3D printers to make new parts for their cars that manufacturers no

longer make. I have a toy plastic computer from 1963 (very limited with a 3-bit display but works) and someone wrote plans for the parts and I have printed some parts. You can also buy programs and you can make your own programs/specifications (I have not gotten that far. A great site for tons of items is [thinkiverse.com](http://thinkiverse.com)

Being used to increase our production in the USA of face shields 3D printing has been around for about 20 years but only in the last few years has the size of printers gotten smaller and available to individuals and the price has fallen greatly.

The filament (ink) comes in different colors and is on spools and the spools of filament look like the spools of filament to

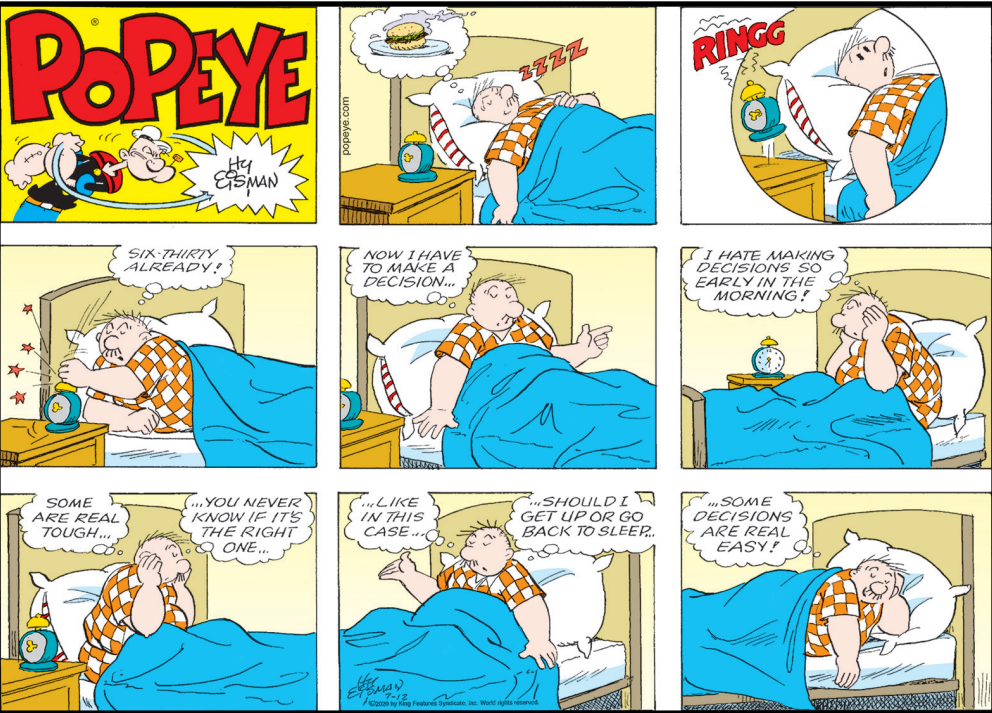
use in a weed eater to trim weeds. There is filament that is plastic (common) and plant based (environmentally better and safer for parts around children)

We will see 3D printers used more and more for individual and mass manufacturing is my expectation. They are being used by big manufacturers to individuals now.

# Introducing: *Mike the robo-goat*

The bond between a beloved pet and its owner is a relationship held to standards equivalent to second to none. While there are many species and breeds available to choose from when selecting the perfect pet companion, not many come to the comparison to a living, breaking robo-pet such as Mike the goat.

Representing a breed of his very own, Mike is considered to be Emanuel County's first and only robo-goat. How, one may ask? Well, Mike's life wasn't intended to be as different as it seems. However, with an owner who refuses to see her pet sink since his entry into the world, Mike has lived a different life than any other goat, and has a burning desire—hotter than flames, one could suggest—to continue forward with his will to live.

Mike is a life-long native of Emanuel County. He was born approximately three years ago in the backyard pasture of his owner and was rejected by his mother after his arrival. Noticing what had taken place, his owner, Tiffany Oliver, took over care of the abandoned kid to see that baby Mike was provided with the necessities that any newborn would need to survive. She opened the doors to her home for the abandoned goat, where she raised and bottle fed Mike until he was old enough to be weaned from the bottle and be returned to the pen where he was birthed. The transition didn't quite pan out for Mike, though. According to Oliver, after being relocated to his original habitat, Mike was once again rejected by the goat herd that occupies the fenced-in

pasture. After being rejected not just once, but twice, it became obvious to Oliver that the only herd Mike truly had was his human herd. She then separated Mike from the other goats and built him his own pen underneath a sheltered area of an outside barn.

On December 15, 2018, Mike's new habitat had caught fire during late night hours. From this tragedy, Mike suffered third degree burns on one side of his body. Refusing this event to be a setback in Mike's short-lived life, Oliver reached out to Mike's local vet, Ace Clark with Swainsboro Animal Hospital, who responded to their location to assist in rendering care.

After this visit with Mike's vet, came many more visits along with wound care provided by Oliver, herself. In addition to the provided home care, Mike has undergone multiple surgeries. Yet, more than a year later, Mike still struggled with contracted skin around the scar tissue and opened wounds that resulted from the 2018 fire.

From past to present days, Mike heavily requires assistance and is completely dependent on his owner. In the early

mornings, Oliver assists Mike in standing, and in the afternoons, she assists her beloved pet lay for a good night's rest. When not helping him up and down throughout each and every passing day, Oliver dedicates allotted times to gather branches, shrubs, and grass for Mike to enjoy munching on.

Though his health and wellbeing progressed with time, Mike once again took a turn for the worse after developing arthritis in his joints that prohibited what movement he had regained since the barn fire.

Oliver then began looking for possible remedies that could aid her pal, Mike the goat. She reached out to the vet and eventually, after attempting every remedy available, no other solutions were able to be offered. At this point, Clark encouraged Oliver to reach out to obtain a second opinion from a UGA veterinary clinic. Oliver followed through with this suggestion and even reached out to an Auburn clinic as well. Sadly, both contacts provided no positive leads for Mike's new status.

Disheartened but determined to find an answer for Mike, Oliver then reached out to Ziggy's Refuge Farm, who's

best advice for Mike was a cart or for Oliver to contact Derrick Campana with Bionic Pets. Already having attempted a cart and knowing Mike was not fond of the device, Oliver then reached out to Campana for further assistance.

Campana is the CEO and founder of Bionic Pets, an established ortho care business with a primary focus on creating braces and prosthetic devices for animals. Having already treated thousands of furry patients with mobility devices, Oliver's request for assistance with Mike's condition wasn't unusual in the least when speaking to Campana on the matter.

Oliver received quick and promising responses from Campana since initial contact was made, which led to Mike's most recent status of being Emanuel County's first robo-goat. To begin the process, Oliver had to complete a form and casting process on Mike. The castings and form were then resubmitted so that Bionic Pets team members could mold specific prosthetic braces made personally for Mike and his condition. After sizings were completed, Mike's new legs were shipped in the mail and arrived Monday, July

13. Mike the robo-goat now sports a new walk that features an exciting galaxy-themed art

display on his prosthetic front legs that makes his appearance, and life story, out-of-this-world!

# Wildland fires rage along Highway 56 North

On Tuesday, July 14, around 1:30 p.m., county firefighters from Swainsboro responded to Highway 56 North by Underwood Loop for assistance with a reported brush fire. While en route, a heavy black plume of smoke was observed. An additional Summertown engine was paged in for assistance and responded with a tanker and a quick response 4-wheel drive. Georgia Forestry Commission also sent two Type 4 tractor-plows, one Type 5 engine, and one type 6 engine to assist in controlling the fires.

A dozen fires were reported being located along

the railroad right-of-way from Blun to beyond Summertown. All of the fires were located on the westerly side of the tracks, indicating the ignition stemmed from a passing train.  
At the address of 25 Underwood Loop, the trail of fire ignited stacks of wooded pallets, threatening the home and other surrounding buildings. The flames from the pallet fire impinged of a metal shipping container, used as a workshop, which caused some contents to self-ignite due to radiant heat conduction. Numerous tanker shuttles between Summertown and the scene were required.

This fire was noticed by Kris Riner and Flint Clark of Altamaha Tree Service as they were traveling on Highway 56. These two good samaritans were able to contain and prevent further fire spread by using a garden hose prior to the arrival of any fire apparatus. Both individuals were thanked for their assistance by Swainsboro Fire Chief Strobridge after the fire was contained.  
The weather conditions on that day were 97 degrees, with 30 percent relative humidity, wind speeds of 6 mph, and dew point of 61, all amounting to a heat index reaching more than 100 degrees. Firefighters were on scene for over 3 hours.


