The February meeting of the Emanuel County Board of Commissioners took place Monday, February 19, at 6 p.m. in the Board Room of the Coleman County Office Building. Commissioners Oliver, Sherrod and Thompson were present, along with Chairman Hugh Foskey who called the meeting to order and welcomed guests which included political hopefuls for two commission seats up for grabs this year. Following an Invocation and the Pledge of Allegiance, a motion was offered to accept the minutes of the January regular meeting and a workshop meeting of February 13. The motion was approved. No issues for consideration were scheduled for the public comment section or for old business. Under new business, the first agenda item dealt with temporary office space which will be required during the renovation of the current county office building. Administrator Singletary provided the commissioners with an update on the search for suitable office space. After considering several proposals, the former offices of the Chamber of Commerce across from the Citizens Bank represented the most favorable option for temporary County office operations. 





## Editorials Columns \_\_\_ An anniversary message

It was about this time two years ago, that I started writing this weekly column. The folks at the Forest-Blade were good enough to allow me the space and place to practice the trade that I had spent four years at UGA and a sizeable amount of my parent's money trying to learn. I have enjoyed these last 24 months trying to revive and restore an ambition and a plan that got shelved a long time ago, and I thank the staff here as well as all of you who take the time to read what I write each week. I plan on continuing that until they run me off. But sadly, and of much greater importance this week is another anniversary of a much grimmer, and somber kind.

It was also two years ago that Russian military forces crashed through the borders of the independent republic of Ukraine in a brazen and unprovoked attack on a neighboring country. It was raw aggression, the likes of which has not been seen since World War II. For months, the dictator Vladimir Putin massed thousands of Russian troops on the doorsteps of Ukraine. When it was clear that this threat and intimidation would not be challenged by any of the stronger western nations, the Russian forces barreled through Ukrainian cities inflicting large scale death and destruction on the civilian population and on an overmatched Ukrainian volunteer military. The devastation of civilian life in Ukraine has driven nearly four million people from their homes. They now live in bombed out buildings, underground

utility tunnels, and any other shelter they can find. The peaceful routine of life for over six million people has become a story of refugees and mass evacuation into neighboring countries. Towns have been leveled, lives forgotten, children lost and stolen, families obliterated and more than 520,000 people dead. All of this, the result of the deranged dreams of resurrection of the old Soviet empire and the malevolent power, greed, and maniacal ego, of a five-foot five-inch former KGB agent. Putin has held absolute power in Russia off and on for all but four of the last 24 years. In a month, he will again be awarded another term in a staged presidential election by almost 97 percent of the popular vote. His estimated net worth is over 200 billion U.S. dollars while the yearly income for the average Russian citizen is between 11,000 and 13,000 U.S. dollars. The former Russian spy will continue to push and provoke leaders of the countries of the free world as long as he sees that there is no credible threat to challenge him. The same is true for leaders of the People's Republic of China, North Korea and Iran. It is no coincidence that these nations and others are all working together now, both economically and militarily, to take advantage of the weakened policy positions demonstrated by the current White House administration. Putting all partisan politics aside, it is now time for the strongest nation in the world to exhibit some real backbone in its projec-

tion of power and resolve. ## Cornbread another official reason to love this great state



## Leader, final defendant in Augusta-area drug trafficking conspiracy sentenced to nearly 13 years in federal prison: Operation distributed methamphetamine and heroin

Justin Wayne Fields, 40, of Swainsboro, was sentenced to 168 months in prison after pleading guilty to Conspiracy to Possess with Intent to Distribute,

Distribute, Methamphetamine and Heroin, said Jill E. Steinberg, U.S. Attorney for the Southern District of Georgia. U.S. District

Court Chief Judge J. Randal Hall also fined Fields \$2,500 and ordered him to serve three years of supervised release upon completion of his prison term. There is no parole in the federal system. "Justin Fields and his

network conspired with a Georgia state prison inmate to facilitate methamphetamine and heroin shipments from Atlanta to Richmond and Emanuel Counties," said U.S. Attorney Steinberg. "The investigation and prosecution of this operation and a related conspiracy sent more than a dozen defendants to federal prison, removing their malign influence from our communities."

As described in court documents and testimony, the investigations that led to the indictments of 10 defendants in USA v. Fields et. al in October 2022 and seven defendants in USA v. Wheatley et. al in April 2022, together dubbed Operation Wheat Fields, identified a conspiracy to transport and distribute

The investigation led to multiple searches of residences, vehicles, and hotel rooms that led to the seizure of illegal drugs

Fields' nine co-defendants, along with the seven defendants in the related indictment, all pled guilty to federal charges. Of the 17 defendants, 16 have been sentenced to terms of up to 240 months in federal prison for their roles in

"This sentence is a direct

message to criminals that ATF will not allow egregious violations of our laws go unpunished," said Beau Kolodka, Assistant Special Agent in Charge of the Atlanta Field Office of the Bureau of Alcohol, Tobacco, Firearms and Explosives. "If you traffic guns and drugs, you will be targeted, and we will ensure that you are prosecuted and removed from our streets."

"Those who distribute deadly drugs, such as methamphetamine and heroin, create serious risks to our communities," said Robert J. Murphy, Special Agent in Charge of the Drug Enforcement Administration Atlanta Division. DEA will use any resource necessary to remove these dangerous drug traffickers from our communities." "This sentencing shows

that the GBI and our partners will not tolerate the nefarious acts of those who seek to traffic drugs in Georgia," said Chris Hosey, Director of the Georgia Bureau of Investigation. "These

drugs poison our communities and destroy families. There is no place for illegal drugs in our state, and we will continue to work to remove them from our streets and keep our communities safe."

The case was investigate ed under the Organized Crime Drug Enforcement Task Forces (OCDETF) operation. OCDETF identifies, disrupts, and dismantles the highest-level criminal organizations that threaten the United States using a prosecutor-led, intelligence-driven, multi-agency approach. Operation

Fields was investigated by the Swainsboro Police Department; the Bureau of Alcohol, Tobacco, Firearms and Explosives; the Georgia Bureau of Investigation; the Emanuel County Sheriff's Office; the Richmond County Office; Sheriff's U.S. Drug Enforcement Administration; and the Columbia County Sheriff's Office and is being prosecuted for the United States by Southern District of Georgia.

### News from under the Dome: Week six

The Georgia House of Representatives kicked off the sixth week of the 2024 legislative session on Monday, February 12. We convened in the House Chamber for four days and made significant progress as we passed 34 bills and resolutions by the end of the week to send to Senate counterparts. By Tuesday, we reached Legislative Day 20, which means we are now more than halfway through our 40-day session. With "Crossover Day" looming on Legislative Day 28, we are focused on perfecting legislation for consideration and advancing notable measures on the House floor.

I was honored last week to be named Chairman of the Rules Committee. The committee controls what pieces of legislation will reach the House Floor for a vote.

The House voted on an important measure this week, House Bill 1037, which would create the Georgia Commission on Maternal and Infant Health. Through this commission, this legislation aims to examine the causes of maternal and infant deaths in our state and provide policymakers with a more holistic view of these issues so that we can continue our work to improve maternal and infant health in Georgia.

House Bill 1010, continues commitment to Georgia's families and will expand parental leave for our state employees and teachers.

My colleagues and I also gave unanimous passage to House Bill 1022, the Colton-McNeill Act, which would fortify protections for disabled minors by elevating penalties for acts of cruelty against them. The legislation would address a critical gap in existing laws, seeking to impose harsher consequences for perpetrators who target vulnerable children.

The House also turned its attention toward our state's education system and its workforce with the passage of House Bill 282. This legislation would provide a significant step to enhance preparedness among middle and high school students in Geor-

We also passed House Bill 874, a bill that would require every public school in Georgia to have a functional automated external defibrillator (AED) machine on the premises of school grounds at all times and school-related during functions. This bipartisan measure would with Georgia's align commitment to prioritizing Georgia's students and creating environments where timely medical intervention can significantly increase the

Below I have highlighted a few other pieces of legislation we passed during the sixth week of session:

· House Bill 546, would allow a pharmacist to adapt a prescription drug order, under certain circumstances, by changing the quantity of medication prescribed, changing the dosage form of the prescription and completing missing information on a prescription drug order. Adaptions would be required to be documented and done with patient consent.

· House Bill 814, would amend current law relating to computation of taxable net income to exclude any grants for investments in broadband infrastructure.

· House Bill 872, would allow for dental students to be eligible for the service cancelable loan program when they agree to practice in rural counties with a population of 50,000 or less.

· House Bill 873, would codify the ability of juvenile courts to establish a juvenile treatment court division as an alternative to the traditional judicial system for juvenile delinquency cases or child in need of services (CHINS) cases.

· House Bill 988, would define the term "artificial intelligence" and revise the responsibilities of the Georgia Technology Authority.

· House Bill 1033, or the "Utility Worker Protection Act," would add enhanced penalties for protection of utility workers







#### Hickman: Week six Under the Gold Dome

We are officially more than
halfway through the 2024
Legislative Session. While we
have enjoyed a robust first

On the legislative front, I'm proud to have sponsored Senate Resolution 470, establishing a study committee dedicated to preserving Georgia's vital farmlands. With agriculture being the backbone of our economy and a vital part of our identity, safeguarding our agricultural heritage is paramount.

Additionally, we've made strides in housing security

with the passage of Senate Bill 349, which limits annual property tax assessment increases to no more than 3%. This measure aims to provide relief and stability for homeowners across the state, particularly in these challenging times.

On a personal note, I celebrated a milestone with my beloved Jo Ann—our wedding anniversary. Her unwavering support is the bedrock of my endeavors, and I'm profoundly grateful for her love and companionship.
