# Council "backs up" on speed cameras

The January meeting of the Mayor and City Council was held on January 6, 2025, at 6 p.m. at Swainsboro City Hall. Following an invocation and pledge of allegiance, council voted to accept minutes of the previous meeting. The first item undertaken by council was to amend the agenda for the purpose of adding five items not previously included. Under old business,

council discussed funding for the project involving replacement of lead pipe in the city water system. Council voted to accept a loan from Georgia Environmental Finance Authority for the project. The loan amount applied for was approximately 5 million dollars. The amount of the loan approved was slightly over four and a half million in a forgivable loan consistent (Continued on page 9A)





# This little bed of mine has stood the test of time

According to Mrs. Carolyn Kight Muns, this little maple bed pictured was ordered from a Sears and Roebuck and Company catalog by her mother in the fall of 1944, during World War II. The bed was purchased for Carolyn, who was born January 7, 1945.

The bed came in the rural mail and according to her mother, her daddy put it together. "I don't know how much it cost but they had to pay for it with a money order or it could have been sent C.O.D.," Stated Carolyn.

The wood is in the original condition and only one roller has been repaired during its use. Through the years, little handmade mattresses have been made - as would be expected - for the little newborns to cuddle on. Today, a king-size pillow works perfectly in the bed. "We didn't know about store-bought king-size pillows back in the day," said Carolyn with a laugh.

The thing that makes the bed so convenient is the rollers, making it very easy to be pulled anywhere in the house...right up to the table or beside a big bed...you can see through the slats at eye level. Unlike a bassinet, you do not have to look down into it. The bed is made to only be used a few weeks. As soon as the baby can turn over, it has outgrown it.

"This little maple crib has been around in this family holding newborns for three generations – Carolyn Holder first then June Holder next. During the late 50's and early 60's, it was used by the Holder sisters first cousins ,the Sims, Johnsons and Blackstones, (formerly the Bramlitts) in the Atlanta area. In 1970, it was back home in Swainsboro for Carolyn and June's babies. From

Swainsboro, it went

to Kite for Carolyn's

grandchildren and then to Twin City, where it remains today in the home of Samantha Freeman, with June's grandchildren Coly Parker Freeman and Carley Mae Freeman. Carley Mae, now 13, was the last baby to sleep in the bed.

"From best count, at least 20 babies have used the crib – probably more – through the last 80 years. It is now waiting on the next generation of babies to one day sleep peacefully in it," stated Carolyn.

# A New Year, a new opportunity

to 2025. This first month of the year gets its name from a mythical Roman god named Janus. A study in contrast, Janus is described in Greek literature as a mix of the future and the lingering past and has appropriately been depicted in history with two faces, one looking forward and the other looking back. January is a month of contrasts, the old and new. In another archaic work of literature from much later, the theme of contrast gives rise to another old saving from the world of the ancient mariner. You may still occasionally hear it today. The often quoted line of moral direction is

actually meteorologically accurate; "red sky at night, sailors delight; red sky at morning, sailors take warning". Now it might be starting to feel like eighth grade English class, and I am not abandoning my New Year's resolution to be more positive and hopeful, but so far this year the dawning sky of 2025 seems to be tinged with an expanding red glow and a slightly ominous tone. We are not even at the middle point of January, and the unsettled state of the world unfortunately seems to be increasing in its "unsettledness". Whether it's the anguish and sorrow brought about by the senseless acts in New

Orleans in recent days, or the conflicts and threatening situations that are continuing to bubble in trouble spots around the world, there is a spreading evil at work that seems to have all the characteristics of a "warning". Seldom have we seen more territorial, zonal and regional upheavals and armed clashes going on simultaneously on this planet. I'm not a "one world" advocate, but it is hard to argue the proposition that ripples emanating from one side of the globe don't affect life on the other side. # Wedding bells to baby rattles

After the excitement and flurry of activity of the marriage ceremony was over, we settled down in our own little garage apartment. We had a tiny kitchen, living room, bedroom and bathroom. We had new furniture we bought and paid for by the week. We had a borrowed car.

Around October, it became pretty obvious I was pregnant. I was sick as a dog and wanted to throw up my toenails. A visit to Dr. Brown verified my suspicion and we proudly announced to everybody that would listen we were going to become a family.

Since we had to climb about 18 steep stairs, we decided it wasn't very safe and found a cute little bungalow off N. Main Street and moved in by Thanksgiving. It had the same amount of space but was a walk in from outside, and we felt like we had our own little home.

Our social life was visiting with our friends, Martha Jane and Al, Jimmy and Shirley, and Buck and Bunny and playing bridge at each other's homes. None of us had much money but we had a lot of laughs and enjoyed sharing stories. Those who did have children would bring them along and make pallets for them at their bedtime in one room and we would gather in another for a game of cards.

I wasn't much of a cook then, but I was willing to tackle anything. Sollie, the great white hunter that he was, brought home a couple of squirrels and wanted me to fry them up for supper with some gravy. I was pretty stupid obviously, but if he wanted squirrels, he would get them. He prepared them, and I floured and fried those little things in a pan of hot grease, making gravy just like my Daddy had taught me - flour and water. It looked pretty good. I'm not even going to try to explain what this stuff tasted like but being pregnant and nauseous, I'm not quite sure how I made it through the pro-

Our heat, a little propane gas heater, was cozy and warm. Backing up to it, more than once, I scorched my nylon slip. During the day, I would get in our borrowed car and drive over to my Momma's house and sit in the beauty shop while she worked, thereby getting all the latest local news and killing time waiting for Sollie to get off work.

Around Christmas, or maybe a little later, my Daddy asked Sollie if he thought he would like to work at the shipyard in Savannah where he had worked during the war. Daddy had a cousin who worked there, and Dad said he was sure he could get Sollie a job there if he wanted to. So, here we go off to Savannah leaving our little bunga-

We found an apartment in Garden City which had two bedrooms, a living room, kitchen and bath. Ours was on the second floor and the stairs were not too bad in the front. The back was a different story. Straight down to the clothesline. We didn't have a washing machine or dryer so every day I would put Sollie's dirty clothes in the bathtub with detergent, let them soak, wash them, wring them out and put the pants on stretchers. Then, I hauled them down those wrought iron stairs to the clothesline to hang to dry. If the wind was blowing the wrong way, I would be in trouble. Anyway, anyone who has lived in that area in or near Savannah knows all about the soot from the Union Bag's smokestacks, not to mention the odor. Many is the time that I'd bring in those clothes which had dried, but during the process accumulated enough black soot so that sometimes I'd have to wash all over again. But when you're young, in love, and stupid, things like that don't matter and you only know happiness and joy that you're going to have a baby and be a family living in a vine covered cottage very soon. Yeah,

right. My days were spent washing by hand the

sweet little diaper shirts, long gowns, and bibs that had been passed to me that Momma had made for baby Charly. Then I'd iron them, fold them, sprinkle with baby powder and place in the chest of drawers in anticipation of the birth of my baby. We did have a small black and white television, and I watched soap operas while I ironed. We had no air conditioning, but a big box fan. The floors were black asphalt tile, and I mopped and waxed them to shiny perfection. We had no friends locally. I was lonely, but happy.

Since I had already started seeing Dr. Brown, I continued to see him after our move. Daddy helped us find a car and we would drive back to Swainsboro for my doctor visits and Sollie's National Guard duties. When it was near my due date, I went to Momma's and Daddy's to stay until the birth of the baby. Momma had made the most precious bassinet, decorating it with white tulle, satin, and little tiny ribbons of pink and blue. It looked like a mini casket! I was in business! Bottles, nipples, rings, caps, pot for boiling were on hand. All I needed was to get the show on the road and have that baby. And he was going to look exactly like my sweet brother, Charly, who was about 4 years old at the time although I had no idea of the gender. I waited and I waited. Two weeks, three weeks, and no baby.

It was the middle of June and watermelons were ripe, and I love watermelon! Daddy brought home a huge watermelon one day, sliced open that thing and I ate watermelon like I'd never had anything to eat in my life. About dark, I began to have the stomach ache from hell. I thought to myself, now you've done it. I huffed and puffed and waddled around trying to get comfortable. Then,

we all decided maybe it wasn't the watermelon after all. Duh. Maybe I was actually in labor. A call was made to Sollie who was in Hinesville at summer National Guard Camp. He jumps in our little red Ford and races to Swainsboro. Somehow afterhegets to Swainsboro, the pains just stopped. I mean, stopped! What the heck? Now what? Sollie had driven 90 miles home at 100 mph for nothing. He went on back to Hinesville.

Sollie probably had not gotten out of town good before those pains came back with a vengeance. I'm talking serious, stick stack, no take back, pains that left me knowing there was no doubt this was it. By the time Sollie drives up to his barracks in the wee hours of the morning, they tell him I've gone to the hospital, and he needs to come back. OMG. Now, he's got to turn around and drive the 90 miles back in time to get there for the delivery. God was surely with him because I'm sure the needle circled the dial, and he drove like a mad man to get back to Swainsboro to see his baby be born!

As it turned out, it was well after daylight, but sure enough, the beautiful baby we were looking for came into this world sporting a whole head of hair, hairy legs and arms, beautiful blue eyes, and all 8lbs 8 oz. of him looked nothing at all like Charly, but he was the most beautiful baby we





dealing with repairs the Wastewater Treatment Plant, repairs Wastewater Transfer station, and the replacement of a tractor for grass cutting were postponed due to the emergency absence of the Clearwater Solutions project manager. The next issues discussed were brought by citizens who spoke on various problems within the city. David Hall addressed council on the trees, limbs and other debris in ditches and on the city right of way. Julia Carswell spoke concerning programs for young school aged children, the condition of roads in some neighborhoods and gun violence that continues in various parts of Swainsboro. In the next order of business, council agreed to repairs at the Police Station air conditioning totaling \$13,700, repairs to brick and masonry at City Hall for \$21,900. Council also agreed to changes associated with financial management at the Police Department necessitated by changes in the Chief position. Next, Council heard from the new Police Chief. Chief Riner requested the approval by council of the establishment of a new division within the department. This new division would be known as Training/ Special Operations. The new Chief explained the need for this unit as a

and indicated Sgt. Adam Kersey has special certification and would advance to Lieutenant grade to chair the new division. Council voted 5-0 to approve. Councilperson Sconyers next presented a proposal to posthumously honor former Fire Chief Mike Strobridge and his dedication to the city fire department. Council agreed that the headquarters building of the Swainsboro Fire Department would be named in honor of the late Chief. The motion was carried by council. Another item for the evening that was added by amendment to the agenda was an explanation of House Bill 581. City attorney Levis gave a summary of the bill's provisions and a timetable for opting in or out. The bill was passed state-wide in the November election and is seen as a possible cap to counter rising property taxes on residential assets. Levis explained that no action was necessary if council did not choose to opt out. In other action, council voted to charge fifty cents per 100 gallons of water for sale to contractors and others at city water filling stations. Council then discussed new committee appointments. No changes were taken pending later action. In another last-minute agenda change, council decided to revisit a controversial move from an earlier meeting involving "speed cameras."

on Tiger Trail. In a complete about face, council approved a motion to rescind the motion from an earlier meeting to install speed cameras on Tiger Trail and then approved a motion not to install speed cameras on Tiger Trail. There was no discussion concerning the reversal. In other action related to cameras, council did approve a request by Chief Riner for installation and leasing of cameras devoted to the prevention of more serious criminal activity. In closing action, council postponed any action on appointments to other municipal committees and approved the issuance of game room licenses for two locations previously applied for. The last item before adjournment of the meeting concerned the condition of the Swainsboro City Auditorium. Carol Donaldson, senting the Sunshine House asked for the city's help and awareness in maintaining the standard of operation and appearance of the facility. Donaldson emphasized the value of the city auditorium to this community and appealed to council not to overlook how many organizations such as The Sunshine House rely on the auditorium as an essential part of their operation and financial support. Mayor Bennett commented that they would include that on next month's agenda. At this point, the meeting was adjourned.
