It's lucky Friday the 13th, Sierra Way to open

According to a post from Kern County Supervisor Phillip Peters, in a Sierra Way update he gave on Facebook, Friday December 6, a few unexpected issues came up, which the county had to deal with on the Sierra Way project.

However Peters still expected the opening of Sierra Way to be Friday December 13. He also dispelled false information about the possibility of a ribbon cutting. The opening will not

include any ribbon cutting according to Peters.

The issues that needed work at Sierra Way were related to installing guardrails at the construction site. Peters claimed these would be minor fixes and would not take more than a week. He said, "We do not want anything to interfere with opening it as soon as is safely possible. Thank you."

The thoroughfare from Weldon area into Kernville had been closed for months in relation to storm damages, causing many locals in Kernville concern about the inability to safely leave during evacuation events.

Residents from Weldon paid more money for gasoline and had to travel many more miles, to dump their trash, as a result of the Sierra Way closure.

This topic packed the Kernville Chamber of Commerce meeting hall, with irate locals expressing anger toward the County, when public works engineers and the supervisor came up to talk about why the repair project took longer than expected.

Part of the issue was an unworkable FEMA design and the need for the county to find funding for a better design. Ultimately the project continued.



CDF &W delivers fish to Isabella Lake

Anglers may be very happy to find more fish, in their favorite fishing spots, in the coming months. The California Department of Fish and Wildlife brought Isabella Lake two truckloads of fish on, Monday, December 2. Fire crews helped do the unloading at Red's Marina according to the president of the Kern River Valley Chamber of Commerce (KRVCC) Fred Clark.

He told the Kern Valley Sun, "The fish that we are currently raising in the pens are provided to us by the Department of Fish and game. And they are not associated with the fishing derby itself."

The KRVCC raises those fish within the pens with multiple volunteers feeding the fish, three times per day, seven days a week, rain or shine.

After delivery Clark told the Kern Valley Sun, "It was amazing. We had a couple of different squads from United States Forest Service showed up to assist with the trans loading from the delivery trucks to the pens."

He said, "If it wasn't for those two stations, coming to us with the assistance, it would have made the job very difficult. Those young men busted their backsides carrying buckets of trout from pen to pen and just did an amazing job assisting us and making it happen."Clark said that the chamber's volunteers raise the fish for, on average, about four months.

And then the chamber releases them into the lake so that the angling community will have some fish stocked in this lake.

The KRVCC started this program a number of years ago when Department of Fish and Wildlife reduced the amount of fish they were stocking into Lake Isabella. "We wanted to make sure that there was always fish in this lake for the anglers to catch and enjoy," he said.

The chamber buys the fish food, after fundraising throughout the year, and from some of the events the chamber puts on. "We allocate on average between \$6,000 to \$8,000 per year for fish food. That seems to be about the average amount of money we seem to have spent, over the past five or six

years, per year," Clark said.

"There is roughly 10,000 trout in the four fish pens. And the fish that the chamber gets from the Department of

Vets to be honored with wreaths at local cemetery

Orion Sanders recently spoke on the topic of Wreaths Across America Day. Sanders invited the public to attend an event celebrating Christmas and honoring those who served the military and are buried here, On December 14, at 9:00am, at Kern River Valley Cemetery District at 8441 Burlando Rd, in Wofford Heights.

Please come place wreaths at the headstones of our heroes. Even before Sanders became District Manager, for the cemetery district, he founded Sarge's Wreaths 4 Vets for the purpose of raising money to hold such events honoring the veterans at the local

cemetery. Sanders said, "I just wanted to remind everybody that December 14th we have National Wreaths Across America Day.'

Sarge's Wreaths 4 Vets attempts annually to reach the goal of attaining the close to 900 wreaths he needs to cover all the gravestones of veterans buried at Kern River Valley Cemetery. Sanders said that there are 885 veterans, buried in the cemetery, if you include the six veterans buried at Cottage Grove Cemetery

"If you want to, come out and help us place out wreaths," Sanders said. "National Wreaths Across America day is a celebration to remember and honor our veterans in our cemeteries. There are over 4200 locations around the world that participate in National Wreaths Across America day."

Sarge's Wreaths 4 Vets raises money and then purchases the wreaths. The wreaths are transported the day before the National Wreaths Across America Day. Sanders said, "We have a very short ceremony at the cemetery. And then we place wreaths on all of our veteran headstones."

Sarge's works very hard to assure that every headstone gets a wreath. "Sarge's is just a way for us to remember our local heroes that are buried here. National Wreaths Across America Day is done in every veteran cemetery across the nation, and every participating public cemetery, which is what we are," he said.


Organizations participating in the event included United Way, KRVBC, Hopester, Pregnancy Resource Center, and Boys and Girls Club.

I saw writing on cave walls stating who they were and when they visited, a banana peel, orange rind left behind, and graffiti in the back of the cave. It is tragic when someone visits any area without regard for environmental degradation or others who will visit after them.

Individuals are responsible for creating the trash that clogs our waterways, pollutes our forests, and ruins natural beauty. Unfortunately, it is up to individual people to clean that trash up. A pollution cleanup project in your area is a great way to improve the health of



nection between humans and the health of a river's ecosystem. Furthermore, reflect on the following psychology terms and how they contribute to a mindful understanding of the ecosystem's health: the dominion/connection paradigm, the Weber-Fechner law, and environmental

The Weber-Fechner Theory focuses on whether "a person will be able to detect a difference between an original stimulus and a new stimulus in the environment." By adequately removing pollutants, we can change the stimuli in our environment, which will

benefit the ecosystem. Focusing on properly removing pollutants shifts our mindset to how humanity consciously extends its dominion over the ecosys-



tem through contaminants. Moreover, do people lack the moral agency to "pack in, pack out" because the pollution is "out of sight, out of mind" after leaving for the weekend? Also, if they return to the area, would they respond to the new stimuli of pristine river beach or lack cognizant discretion for the environment?

The leave-no-trace mindset focuses on an ecosystem's connectivity and how the working parts need to be protected so that life can continue; the health of ecosystems is intrinsically connected to the health of the whole Earth.

Please! Leave no trace.

Fred Clark wins Man of the Year

According to Kern River Valley Chamber of Commerce president, Fred Clark, there were a lot of people nominated for this year's Man of the Year slot, yet somehow he was nominated and selected.

He told the Kern Valley Sun last week, "I will be completely honest with you. Don't get me wrong; I'm honored for being nominated. I appreciate it very much. But I personally would have liked to have seen a different person receive Man of the Year."

While it's hard to imagine anyone wanting to turn down the honor, apparently Clark tried to turn it down and the chair for the committee determining the winner shooed Clark's protests away.

"I don't believe it's in the best interest of the Kern River Valley Chamber of Commerce to have a current sitting president nominated for that award. I feel that it looks bad upon the chamber because there's so many people that do so many great things. And I feel like they (the committee) are looking within their own spectrum for that nominee when they do what they

did," Clark said. "I personally nominated a different individual in the valley, that they (the committee) obviously chose not to support because apparently there was a number of nominations for myself, which I'm honored with that.'

Clark also stated that he would have preferred the committee waited until he was out of the presidency before honoring him. 'I just hope the public doesn't tantalize the chamber because of this. All I care about is the image of the chamber nothing more. We do a lot for the KRV and I wouldn't want us to be negatively impacted by this decision Clark was asked to join the

board of directors for the KRV chamber in mid 2017 because the chamber had open seats. He was on the board for a few months before the secretary of the chamber left and moved out of state. He was approached to become secretary of the chamber. In 2019 Clark was the vice

president of the Kern River Valley Chamber of Commerce. The president then resigned the position and Clark was seated as president of the chamber. Fred plans to continue with the chamber even

after he leaves the presidency next election. Clark said the position of president involves a lot of responsibility.

Clark and his family moved to the Kern Valley full time in November 2014. He started his business the Fred Clark Farmer's Insurance Agency as insurance professional in November 2016.

Prior to that Clark grew up in the packaging industry, "literally from ground zero," he said. In October 1990 he went to work for West Coast where the owner Keith Hoching became his business mentor. Clark said, "Keith is the one who truly taught me everything on how to operate and handle vourself in the business world. He was basically my mentor in life.'

Clark eventually went to work for Reserve Truck Lines, a trucking company, which was a family owned business where he became a key part of that business and he worked sometimes 16 hour days. When Clark finally pulled the trigger, left the transportation industry he was approached by Farmer's Insurance. He said, "They found my resume online." Clark was thereafter able to step

back into the role of how his mentor Keith taught him. "It's his focus and teachings that really got me to where I'm at." Clark said. As long as there's a need for an insurance agent he plans to serve in that capacity. Clark moved his family

to the Kern Valley after they inherited a home and were preparing to sell it. That was when Fred and his wife Lana found that their son Hunter, who was a special needs child, blossomed more when they were up here in the valley. With Hunter doing better up here, than where they formerly lived, the couple decided to shift their life, and moved up here from Moreno Aside from his mentor, Clark

making him a better person. And therefore Clark credited his wife's efforts at home educating their son, for making him the excellent person their son Hunter grew to Clark has been involved with

also credits his son Hunter for

Exchange Club where he has served as president, twice in the past 8 years. He runs the Isabella Fishing Derby, as chairman, which

"It's called the New To Town event. It is for anybody who is new to town. And that is up to their own interpretation," Powers said. "Sometimes people who have been in town for awhile can still kind of feel like a newcomer.'

Sierra Shared Spaces would be connecting people to their neighbors in partnership with Kern County in the Neighbor to Neighbor program, Kernville Cowork and Kern Valley Hospital Foundation.

Part of Powers' inspiration for the event was that often people coming into town, that have online or digital jobs, visit Kernville Cowork and have common questions relating to where they can find out what events occur in town and where they can get connected.

Powers said that there is also a list of things people need to understand, if they've never lived in place like this, such as issues with wild fire season and weed abatement and property clearances; evacuations; how

to deal with septic tanks, propane tanks and swamp coolers. "We'll have some speakers throughout the day that can help with sharing their knowledge, through the afternoon, these topics with an educational portion," said Powers.

A friend of Powers', who held a similar event, was also part of Powers' inspiration for holding the affair. Powers plans to have other organizations there, for people to be introduced to, organizations they can volunteer for. "We're also partnering with the Kern Valley Hospital Foundation, which has had a desire for awhile, to put together Welcome To Town baskets for people new to town.'

Powers explained that he hopes if the event goes well, and if the organizations feel it's worthwhile, and people that come feel its worthwhile, Sierra Shared Spaces would consider doing it annually, or more frequently, to make the valley more welcoming to new people.

"I've been blessed, to always be a local, since I was born. But it's easy for people that are new here to tend to still feel like an outsider, even after they've lived here for a little while. So we want to change that. We want people to feel welcome, and like they're part of the community. Let's welcome people to the community."



Famed artist completes Art and Community Center murals

The world-renowned artist known as Vyal One finished painting the murals he began at the Art and Community Center of the KRVAA. "Vyal One did everything," Kimberly Salazar told the Kern Valley Sun, Wednesday, December 4.

Remember to take a look the next time you happen to pass by or visit the center in Wofford Heights.

The internationally famed tag artist, known as Vyal One, began this project painting murals in the windows, at the Art Center building, in early July. The Kern River Valley Art Association (KRVAA) commissioned him for this project. He ended up recently making the murals into one big mural by painting a bit on the front of the building and the benches up front.

When he began the project, last summer he told the press that he'd soon return, to finish up. "They want me to paint all of the windows on the building. So I wanted to just go up there and meet everybody and do a little bit of work so that people can see what type of work I do. And then it's not such a big surprise, or anything like that, when I do paint the rest of the building. I wanted to kind of just give an hors d'oeuvrve, so to speak."

Keeping in mind that his inspiration for his projects and his style is like someone writing a book, and this was only one in his many pages. The continuation of the story is his illustration without using words. He said, "In my travels I'm trying to connect spaces and connect with the space. So I've come to develop this style of painting and imagery that seems to be

universal and people's connection to it. I always put an eye in for the representation of consciousness and the living breathing spaces that we come into as artists sharing our work and collaborating."

Describing his artistic expression as an organic abstract style, Vyal One explained that his work incorporated a lot of organic flow, representing female energy. "You always hear about masculine energy, of having big buildings and sky scrapers. And I try and reconnect to the feminine with doing more work that's more fluid, and more organic, and more airy, in a sense, so that it feels very soft.' Vyal One wanted people to

feel like they could walk into his project. "I want people to feel like they can touch it and maybe get some dust on their fingers. Like you touch a butterfly wing, you get some of that dust on your fingers. It's really heavily nature inspired. But it's a lot of really subtle odds The bubbles he paints have

always felt very powerful to him, as a very strong image, because it is literally one's breath inside of water, which to him is amazing. "I think, today, people take a lot of small things for granted," he said. Vyal One grew up in Los

Angeles with very few places to connect with nature. During his professional years he has sought to connect with nature. "Being from the city you're caught up in the rat race," he said. "I do need to reconnect often, as it is, to nature. But even when I'm in nature I still want to paint. Places like Kern Valley are really amazing."

Vyal One began his art during his childhood at around age 12. He also started to see, in places like New York and Los Angeles,

in the late 1980s, early 1990s, this type of work within magazines one could buy to see artists, from around the world. Seeing such works inspired him to move full speed ahead.

The artist participated in an exchange program, in Berlin Germany, in 1995, which was one of his first big projects. Seeing other artists treat their artistic pursuits as a profession inspired him to do the same upon his return home. Growing up in East L.A. Vyal

One saw many murals the local artists painted, during the 1960s, '70s, and '80s, such as the East

had respect for all the work those artists did that resonated with him. His work, others of the KRVAA

Los Angeles Streetscapers. He

described as the tagging style, or tag art, was based upon a tagging art culture that he felt connected to earlier on. He described tag as a signature or symbol of the artist although he has since grown beyond that in his artistic pursuits. "As I got older I wanted to do more with the spaces that I was coming across. I wanted to show more appreciation for the places that I was painting, but also the community I was painting in. I

wanted it to have more meaningful connections." He said, "You find time to become this alter ego and you can go around and meet with others that share this passion, that do this type of work.'

Vyal One previously created a community events space in Los Angeles, for car shows and other events, showcasing the works of other artists he knows. He is well known as "the guy that paints the

Author Olive Swan can be found ministering often in churches around the valley. The Kern Valley Sun met her at Knuckle Up Ministries' Peddler's Faire, last year, and recently at the Kern Valley Exchange Club's Pastor Appreciation Lunch. Her current book is titled, "Ac-

cessing the Presence of God." The purpose of the book is to assist the church in accessing God's presence in a tangible way using ones senses for that purpose to perceive God's presence. "I wasn't intending to write this. The Lord was

giving me little whispers that this needs to be written," Swan said. She explained that there are

churches waiting for finances, healing, assistance, truth and direction. "These things can only be found in God's presence," she said. Because of their waiting for healing, trusting and waiting, churches need the presence of God. They may be missing some element to access the presence of

The book is 24 chapters and over 224 pages, in four parts. The first part is where to start to access the presence of God. Swan uses Scriptures, going back over the Scriptures, to reveal how the patriarchs delved into God's presence,

Not a modern day altar, like those made for idols, but the one God requires without idols.

The second part of her book talks about those things, which displease God, holding back His presence, such as sin. "We come to God being embraced by Him so that we become new creations," she said. "The sanctuary of God is a holy place."

The third part of the book is about preparing one's self to meet God the King, having a mindset and spirit of expectation to glorify God, receive answers, worship the Lord, and get relief. "Meeting your king takes some preparation,' she said. Swans' book leans more God and seeing the glory of God when the Lord takes over with His agenda rather than mans' agenda. The fourth part of the book is

about the protocols of respecting and honoring God, a real meeting with the Lord, and not holding back God's fullness, ultimately being able to receive answers from the Lord. The book, Accessing the Presence of God, is attainable on Amazon. "This book is really saturated with a lot of gems," said Swan. "Someone who picks it up won't be disappointed.' Swan's ministry primarily

focuses on counseling women as well as writing her books to edify the spiritual lives of others through her 501c3, which is called "Feministry."

She has written over 50 books. Her calling from God is to assist women through counseling them in their marriages and relationships. Swan says Her books are like stepping stones in her life into femininity.

Former Broncs athlete gets Hall of Fame nod

Rusty Muncy, a 2012 graduate from Kern Valley will be inducted into the Briar Cliff University Athletic Hall of Fame. His athletic prowess at the college level was recognized, and now he will be a Hall of Famer. Muncy who grew up in Bodfish was a stand-

out Broncs athlete, track and field was where he really excelled. He also took his turn on the football field. Muncy, after graduating from Kern Valley went on to be a Charger at Briar Cliff. The next level was just an extension of his high school talents. His best event was the 400m hurdles and he perfected this at college. He would also be part of the 4 x 400m relay team that he would qualify for the NAIA National Meet. Because of his success he gained All-American status for the relay five times. Muncy was selected as an All-American once in the 400m hurdles. According to the Briar Cliff University

website Muncy was selected for quite the number of accolades. "Rusty Muncy had a decorated career for the Charger Track and Field team, being named a six-time All-American, nine-time GPAC Champion, and earning All-GPAC honors 27 times during his career. In 2015, Muncy was named the most outstanding performer at the GPAC Indoor Championships, where he earned All-GPAC status in all five of the events he participated, on top of winning the 60m and 200m dash. Muncy qualified for the NAIA National meet in eight different events, earning All-American status in the 400-hurdles once and the 4x400 relay five times.'

Muncy talking about the experience of becoming BCU Hall of Famer said, "When I first received the news that I will be inducted into the 2025 BCU Athletic Hall of Fame I was ecstatic. I was so happy that all my hard work and dedication to the Briar Cliff track and Field program is being recognized. I never imagined that I would have become



such a successful sprinter in college due to coach Brian Christianson for providing me

college. I hope I inspire future student/athletes that even though it's hard or out of you comfort zone, as long as you put your mind to

me specializing in hurdles/jumping going into

it, you can do anything.' Muncy went on to say, "I want to thank with his guidance, support, and giving me the opportunities and experiences to prepare me for college. And being an amazing friend and mentor. I also want to thank all my friends, family sponsors and KV residents for believing and supporting me through my track and

"I am so happy that Rusty has been selected to join the BCU Athletic Hall of Fame. After one year of trying different events, Rusty really burst onto the conference and national stage becoming a 24X All GPAC selection, 9x GPAC champion, selected as the Most Outstanding Male Performer at the 2015 GPAC indoor championships by scoring 30.5 points, named NAIA National Men's Indoor Track Athlete of the Week, qualified for nationals 19 times in 8 different events, and obtaining All American honors 6 times. His versatility and reliable starts on the relays made Rusty extremely valuable to the team's success.' This quote is attributed to Nathan Treinen, Former Head Track and Field Coach, Assistant Muncy will see his named placed in the Hall

of Fame on January 25. The doctrine for the BCU Hall of Fame is, "The Briar Cliff Athletic Hall of Fame was established in 1991, following the 25th anniversary of co-ed intercollegiate athletics at Briar Cliff. The Hall of Fame was formed as a means of recognizing those who have, at some point in their lives, left their mark on the Charger athletic program. The Hall of Fame is designed to include former athletes, coaches, athletic personnel, entire teams and honorary inductees.3 Former Broncs track and field head coach




