Hospital board elects 2025 officers

At the recent Kern Valley Healthcare District (KVHD) board of directors meeting, the board determined its officers on the board for year 2025.

It was toward the tail end of the January 9 meeting that board Director Gene Parks recommended that board Director Ross Elliott become this year's Chair, replacing Katheryn Elconin for the slot. Elconin had served as Chair during the year 2024.

Director John Blythe humbly yet confidently said that he wanted to throw his hat in the ring for the prospect of being this year's Chairman. However he was ultimately fine with whatever the other board members wanted to do about the decision of who would be Chair.

Elliott preferred that the board keep the same slate of officers as last year and that Elconin be Chair again for another year.

Board Director Fred Clark said he preferred to see a fresh Chairperson for the new year, either Blythe or Parks, who had not served as Chair since Clark was Chair. He thought the KVHD board ought to rotate its officers annually.

Parks said he did not have time in his schedule to be the Chair of the KVHD board for 2025 year. Board Directors Blythe, Clark, Elliott and Parks then all agreed with the idea of Director John Blythe being Chair. Elconin said she still wanted to be Chair for another year. Clark asked Elconin how she would feel to be second.

Hospital board meets head to head with staff complaints

During public comment at the Kern Valley Healthcare District board meeting, Thursday January 9, several employees came to the meeting knowing some staff members had circulated a complaint, which was sent to the board and hospital executives.

Hospital employee Kelly Joy Brown-Lewis read a statement to advocate for the concerns of her co-workers, "in an unofficial capacity." However it became apparent that she initiated the original letter of redress under discussion, to the board and executives. It also became apparent that the performance of CEO Jim McGlew, and some department managers, was under scrutiny.Brown-Lewis had addressed the board with a 12-page document circulated among employees at the hospital. She originally requested feedback from employees about what could be done to improve the hospital. "There's consensus among employees and most of our concerns have been previously submitted through the prop-

er channels," she said. "A majority of the staff that I've spoken with feels that their questions and concerns have been largely dismissed."

Issues employees have addressed included: workplace safety issues, maintenance issues, patient safety issues, dietary issues, educational training, jobs and systemic organizational issues. She said, "Employees want to be involved in bettering the hospital for their community and our patients."

Staff requested in the statement she read to be represented at every board meeting and to have monthly meetings with the CEO to address concerns.

The CEO responded saying, "We're very open to having open dialogue

Smile: if you're on the upper Kern River, you're on camera

A unique study using more than a dozen cameras, 730,000 photos and artificial intelligence is intended to quantify recreation on a section of the North Fork of the Kern River now through November 2025.

Southern California Edison is conducting the study as part of its relicensing application for its Kern River No. 3 (KR3) power plant near Kernville. It's current license expires in 2026. It is applying for a new 50-year license.

Several recreation advocacy groups have argued that Edison's operations leave too little water in the river from Fairview Dam to KR3 to accommodate boating and maintain cold-water fish habitat for anglers, prompting the study.

Sixteen cameras are already in place at 15 different locations from the Johnsondale Bridge about 17 miles south to KR3 just east of Kernville. The cameras are programmed to snap

Clark steps down from KRV chamber chair

Whatever Clark feels about becoming Man of the Year, he is happy to be replaced, as president of the Kern River Valley Chamber of Commerce.

Tipping his hat to the new president of the KRV chamber, Clark explained that Karrie Bunting would officially be sworn in at the chamber's upcoming Installation Dinner, at Paradise Cove Lodge January 13. Clark said, "Miss Karrie Bunting is going to be the new chamber president for the next calendar year and she was elected by the members."

Clark is fairly happy to be replaced. "I've had this seat for a little over five years," he said. "I have not been able to dedicate the time, the last twelve months, that's needed. So I'm really happy that we have someone coming in that can put forth a little bit more effort than I can now.

Clark explained that he did not take his decision to step down lightly. He said, "The business that I am in, with the world of insurance, has been changing so drastically over the last two years; I haven't been able to focus as much time as needed within the chamber to ensure that we're doing things the way I want to see them

done."

Clark said he had pondered how the chamber has been benefiting the community and representing the community. And while he could have ran again, he believes a fresh set of eyes, ears, and thoughts is needed to run the team every couple of years

Clark enthusiastically praised Bunting's capabilities. "It's fantastic to have someone with her knowledge and skill set sitting in that seat. I think she's going to do an amazing job."

Clark is also hoping that, as new Chair, Bunting would get some clinics and classes going

Before his vice presidency he was secretary of the chamber. "It needed to get done and I was able to do it," he said. "I'm just hoping

Winter Fishing Tactics

rene lake or a flowing river, January presents a unique opportunity to reel in some impressive catches while enjoying the peacefulness of nature during the colder months.

To effectively target large

the sun warms the water. Midges are small flies that hatch in winter when the air temperature rises to around forty degrees Fahrenheit. These insects provide a crucial food source for trout during the winter months. slows down. Fish conserve energy, and hatching insects wait for warmer days. Trout stay low, waiting for food to come to them. During this season, trout won't respond to flashy, aggressive techniques like stripping streamers or fast-casting wet flies The best tactic is to go slow and find deep, calm water adjacent to faster currents. Eddies and riverbanks are excellent spots for locating trout. Food will drift by, allowing trout to expend minimal effort, making pocket water ideal for fishing. Another important tip is to downsize your fly or bait. It may seem logical that bigger bait catches bigger fish, and in some cases, this is true. However, if your bait is larger than the insects and other food sources in the ecosystem, the trout are unlikely to bite. Opt for something that matches the size of the local bugs. Remember friends, tight lines and leave no trace.

photos every 5 minutes from dawn to dusk. They are expected to produce 730,000 photos through next November, according to Edison's study plan.

The utility will use the Google Gemini Application Programming Interface (API) to create a custom artificial intelligence model to identify specific features in photographs, such as watercraft, to count and categorize river uses, according to the plan.

Though recreation advocates were largely responsible for prompting the study, they aren't happy with what they view as Edison's focus on rafting, as opposed to all forms of recreation, including day uses, hiking, fishing and kayaking, according to comments filed on the study by Kern River Boaters.

They base that concern on Edison's placement of cameras at whitewater boating put-in and take-out locations, and its description of the study as collecting data on "...commercial and non-commercial boating activities on the North Fork Kern River."

The study plan does state the cameras will be able to distinguish between large and small rafts as well as kayaks and other craft, such as paddle boards. But it also states the study "...is not a census of all recreational users on the river. In particular, there are additional dispersed recreation use areas (camp and day use sites) that provide river access that are not included in the study."

Kern River Boaters has asked that FERC require Edison to modify the study to include those camping and day use areas, as well as other river access points, trailheads and conduct onsite surveys.

They also argue that without corresponding flow records, the photo compilations will not give an accurate picture of the power plant's impacts on recreation on the upper Kern. If flows are too low, for example, because the plant is taking more water, boating and other activities will naturally be down as well.

Comments provided by the Forest Service and National Park Service also indicate those agencies are concerned Edison is skimping on its camera study.

Both agencies have asked that all river uses be included in the study.

FERC is expected to announce Feb. 10, 2025 whether it will require Edison to modify or add to studies.

January is one of my favorite months for fishing, as it offers the perfect conditions to catch large, trophy-sized trout. During this time of year, the water temperatures drop, creating an ideal environment for these fish to thrive. Trout are particularly comfortable in cold water, with their optimal temperature range hovering between forty to sixty degrees Fahrenheit.

As the winter chill sets in, the fish become more active, making them easier to locate and catch. The tranquil beauty of winter landscapes adds to the experience, and I love the crisp air as I cast my line. Whether I'm fishing in a setrout, anglers must embrace the differences in trout behavior between winter and summer. In summer, we are greeted with exciting topwater action as insect activity slows. Yet, during the colder months, trout reveal their resilience, feeding on aquatic insects, worms, and other small underwater treasures.

In the beautiful Kern River Valley, we are blessed with the dam, opening the door to fishing the tailwaters. These waters, released from dams, offer a consistent temperature, creating conditions reminiscent of the summer fishing experience.

Midge hatches are common in January, typically occurring in tailwaters during the afternoon when When fishing with midges, use small dry flies just below the surface and adopt a dead drift presentation. The colors of midges can vary depending on the oxygen content in the water, so experimenting with different color patterns can improve your chances of successfully catching fish.

Midges feed on decaying organic matter, such as plant or algae material. Locating the midges' food source can help you find where the trout are. In winter, I have found that fishing between 10 AM and 4 PM is the ideal timeframe for catching trout. During the warmer part of the day, insect activity increases, which in turn leads to more active trout. In winter, everything



Hospital follows up after ER closure

During the Kern Valley Hospital board meeting, Thursday January 9, the previous Emergency Room closure became a topic of concern.

Board director for Kern Valley Healthcare District, John Blythe asked if the hospital was going to be penalized for closing the ER the night of December 28.

Chief Executive Officer Tim McGlew told Blythe that he notified EMS and the State entity California Department of Public Health and had worked with EMS McGlew stated that the hospital handled the event correctly. These issues happen especially with rural hospitals Chief Nursing Officer

Mark Gordon said the state was satisfied with how the hospital dealt with the issue on the night they closed the ER.

McGlew said, "It's the first time in 45 years that I had to close a department like that. We don't take that responsibility lightly.'

Board director Ross Elliott said that the policy and personnel committee talked about the event, in depth, and is confident this issue would never happen again.

Gordon said he devised a float pool, with a three-hour

spouse of someone who came into the hospital, when the ER was closed, and the doctor wanted to transfer the patient by ambulance. It turned out the patient had an emergency surgery after he was transferred to another facility.

The issue of Kern Valley Hospital closing its ER happened when, during the holidays, some staff was out of town, while others called in sick, so that not enough RNs would be available to work, although a doctor and technician were still avail able, and an RN was on call for emergencies after their shift concluded. McGlew and Elconin assured the press that, during the closure, transfer services through ambulance and copter were still available.

Stacy Goins wanted to provide an overview of the FRC programs for the KVEC. She said, "One of the programs that we just finished is our Angel Tree Program for Christmas. Our program was started 15 years ago.' Goins said that the Angel Tree Program was originally started for high school students that were not receiving gifts at Christmas. However, over the years the program has developed to serve kids ages 9-18. The only requirement is that the child is a resident of the Kern River Valley. Goins explained that the scope of FRC is more than just Kernville, Wofford Heights, and Lake Isabella and South Lake areas. It also services all the way through Glennville, Walker Basin and Havilah areas. "We cover over 695 square miles. So it's a really big territory for us to cover," she said.Parents

have to come sign up for the Angel Tree program at the FRC office. Some parents don't have transportation to the center. Therefore the FRC helps parents sign up if they need help.

This year the FRC's Angel Tree program worked along side local Toys for Tots Coordinator Yvonne Pickerell, signing up and delivering the toys. That program serves children age 0-18. On January 7, 2025, the Kern County Board of Supervisors enacted Franchise Ordinance F-709. Ordinance Franchise F-709 granted Erskine Creek Water Company ("Grantee") a 20-year non-exclusive franchise ("Franchise"), replacing Ordinance F-479, to construct, install, maintain, inspect, operate, repair, renew and remove a publicly regulated utility pipeline together with the appurtenances and equipment necessary or convenient for operation thereof. The nominal internal diameter of the pipeline, rounded to the closest inch, shall not exceed twelve (12) inches. The principal purpose of the franchise is the transport of domestic water in and under any and all public highways, pub-

lic roads or rights of way now or hereafter dedicated to public use for roadway purposes and expressly accepted and/or declared public highways by the County (including, but not limited to, the Kern County right of way for Lake Isabella Boulevard, Erskine Creek Road, Alta Sierra Avenue and Edith Avenue), which are within the County of Kern, and are within Section 31, Township 26 South, Range 33 East, M.D.B.M., Sections 1 and 12, Township 27 South, Range 32 East, M.D.B.M., and Sections 5 and 6, Township 27 South, Range 33 East, M.D.B.M., but not included within the limits of an incorporated city.

Throughout the term of the franchise the Grantee and its successors or assigns shall pay to the

County an annual franchise fee amounting to two percent (2%) of Grantee's gross annual receipts arising from its use, operation, or possession of the right of way privilege; provided, however, that such payment shall in no event be less than one percent (1%) of the gross annual receipts derived from the production or sale of utility services within the limits of the County for which the ordinance is awarded. Grantee shall file with the designated agent of the Board of Supervisors, within three (3) months after the expiration of the calendar year or fractional calendar year following the date of the granting of the franchise and within three (3) months after the expiration of each calendar year thereafter, a verified statement showing in detail the gross annual receipts arising from the use, operation or possession of the franchise during the preceding calendar or fractional calendar year. Grantee shall pay to the County, within 15 days after the time for filing the statement described hereinabove, in lawful money of the United States, the annual fee due. Any neglect, omission, or refusal by Grantee to file the verified statement, or to pay the franchise fee at the time or in the manner provided, shall make the Grantee subject to penalties as detailed in Sections 11, 13, and 14 of Ordinance F-3 (Fourth Revision), and/ or constitutes grounds for declaration of forfeiture of the franchise and of all rights thereafter.

On the **7th day of January 2025, at the hour of 2:00 p.m**., in the Chambers of the Board of Supervisors, in the Kern County Administrative Center, 1115 Truxtun Avenue, Bakersfield, California, the Board of Supervisors of the County of Kern adopted an Ordinance establishing the schedule of Solid Waste Management Program Service Charges (Gate Fee and Bin Fee) for Fiscal Year 2025-2026 for all non-residential property in the County of Kern. The Ordinance establishes the maximum rate for the Gate Fee, for non-residential waste, to be set at \$67.25 per ton_A transfer fee of \$11.60 per ton will be added to the Gate Fee for non-residential waste delivered to any Transfer Station. For non-residential customers subscribing to bin service from a Franchise Garbage Hauler, the Bin Fee will be set at \$3.48 per cubic yard. A transfer fee of \$0.60 per cubic yard will be added if the waste is delivered to a Transfer Station. Table A is a detailed list of the increases in the chargeable rates.

Additionally, the Kern County Board of Supervisors (Board) may approve future rate adjustments in the Gate Fee and Bin Fee based on the prior fiscal year Consumer Price Index (CPI) for Los Angeles-Long Beach-Anaheim, CA (Series ID: CUURS49ASA0) without a protest hearing for an additional two years. If, in any year, the rate adjustment approved by the Board is lower than the amount resulting from the application of the CPI, the difference may be carried over and applied by the Board to future rate adjustments. In the event the cited index is substantively changed or is no longer published, the Board will select a substantially similar index.

The Public Works Department has considered the environmental impacts of this action and concluded that this action will not have a significant effect on the environment and the action is statutorily exempt from further CEQA review per Public Resources Code Section 21080(b)(8) and Sections 15061(b) (3) and 15273 of the California Environmental Quality Act (CEQA) Guidelines.

with our staff. It's the only way we can accomplish anything. So just understand that's what's going to happen." McGlew noted that the hospital was already working on changes as a result of the statements the hospital received from employees.

He said he appreciated the comments from Kelly and staff. McGlew said some of the things, which were helpful, would be addressed and would result in changes and fixes.

Then he stated that other things within the 12-page letter from staff were factually inaccurate, that may have been based on misunderstandings, and he gave some examples of those misunderstandings. One example was the claim within the employee complaints letter that the hospital didn't pay for a specific training for nurses and he said the hospital pays for that training, although it's not even required for the hospital to pay for it. And he said

the misunderstandings might have been based on lack of information.

Then McGlew said the hospital responded to these issues and concerns in an update to the employees, for educational purposes, and

in conversations to address employee concerns. McGlew said his going into each department regularly to ascertain concerns from staff was a more efficient way for him to find concerns from

employees than a regular meeting would be. Both directors John Blythe

and Gene Parks Sr said they thought the way the board meeting room was set up was uninviting and McGlew agreed and said the hospital was planning to address the issue so the public and staff would feel comfortable attending the board meetings.

McGlew said, "The letter claimed to frame the responses from an unbiased and respectful manner. I have to disagree. A number of these were done from the perspective of an attack on the managers and so forth.

I've gotten considerable feedback from the staff highly upset with the letter and how things were framed." He said he'd work with staff and has always had an open door policy.

Parks asked McGlew why he hadn't already talked to staff before hand and if he planned to continue. McGlew said he planned to continue working with managers and he already had been doing so.

Board director Ross Elliott said the hospital is giving opportunities for managers to express their concerns and reminding managers to come to these meetings.

Board chair Katheryn Elconin said, "Employees here, you're still part of our community. We are here to represent you." she told the employees present during the meeting that if they're not comfortable going to their manager or to the CEO they could come to a board member and speak with them directly.

Registered Nurse Danielle Welzig appeared to be on the brink of tears as she said, "I don't think it was disrespect-

ful." She said employees felt frustrated and some of them felt shutdown or unheard. She said the ER shut down was devastating as was hearing the backlash about it. "Some of the things we are asking are not huge changes," said Welzig.

Elconin thanked employees who did attend and assured them the correspondence was heard and is appreciated. She said, "Everybody on the board wants to meet the needs, wants to see the hospital grow. We depend on you. The community depends on you."

Nutrition Services Manager, Registered Dietician Nutritionist, Dr. Tiffany Frieson came to represent the voice of her department. She said, "My staff saw this document on Sunday, in the cafe, and they were just appalled by it because, as most of you all know, there were many pages about my department.'

She indicated food is personal, and said her kitchen is amazing and felt the document was hurtful and felt attacked by the document employees and Kelly provid-

ed the executives and board. She said her dietary department is inspected by the state and passes its required inspections. She summed up that her department staff often feels blamed and accused based on assumptions. She hopes going forward people would address any questions

and concerns directly. Brown-Lewis expressed that employees did not feel the process of complaints through proper channels are being properly addressed

McGlew said it was a new day and he has an open door policy.

Elliott referred to the document as a "sneak attack" and said he hoped staff would handle things differently going forward. He hoped staff would identify the claims in the document that were inaccurate.

McGlew said these issues were not unusual for hospitals and felt at the end of the day they all love each other and they're a family. He thanked his administrative staff for spending about seven hours drafting the response to the letter from Kelly and staff.

Elliott said there were claims of misogyny and they need to be reported immediately through the proper channel and dealt with.

Board director Fred Clark thanked the staff for addressing issues and said he hoped the staff would be able to keep up on issues by attending public meetings of the board so staff knows whenever the board addresses such complaints.

Clark said during trustee comments period that he hoped staff would continue to bring up concerns to the hospital officials. He thinks it's critical that staff continue to voice their opinion and hoped they'd keep up the momentum.

Blythe said he feels as an elected public official the board is obligated to face the public and hopes more employees would come to the meetings going forward. He said employees need to feel like they're heard. This place cannot operate without addressing their concerns.

the new Visitors Center as previously hoped.

"We are solely funded through our membership dues and through our events." She said the chamber has some money saved. And as a rule of thumb the chamber doesn't normally like to rely on grants from other organizations because of the strings attached to such funding

hospitals have been launching similar agreements, to help veterans so that they don't have to go to the VA elsewhere to attain permission before seeking services locally.

McGlew told his board he was grateful to Vince Fong and Samantha Mitchell, Constituent Services Representative from Fong's staff, for Fong's support in the process.McGlew told the board that there are about 900 veterans in the valley. The hospital and VA would be marketing this agreement once marketing details were finalized.

McGlew told the Kern Valley Sun, "We have a transport service; with a

grant from Kern Health Systems we bought three vehicles, as well as the staff to run those. And that has allowed us to take patients from their homes to the hospital, to their clinic, to doctor's appointments, even down to Bakersfield for specialist visits. And this is all part of putting this together. There's no cost for it.'

McGlew said he spoke with the administrator Gregg Davis at the hospital's clinic and heard that the veterans have already been coming in and scheduling appointments locally.

McGlew and Lopez were coordinating the details to get the word out to all the veterans.

Lopez said, "We're very excited that Tim McGlew hasn't relented on this and

that they're expanding this care to the region. Like he said we're going to meet to discuss the details. We want to be able to inform all of our residents in Kern County about what the process is going to be. Once we have all that straightened out, we'll be informing the whole community how to navigate the process."
