War truck returns home

CLINTONVILLE – The FWD Seagrave Museum received an intact and running WWII artillery truck from the Netherlands in late April.

The truck was built in 1945 by FWD (Four Wheel Drive) Corporation in Clintonville and shipped to Europe near the end of the war. The truck was in a private collection that was sold at auction in December of 2024. It is unclear what country ordered the truck, but it is believed to have been built for the Dutch military. One clue that indicates this is that there is an original manual for the truck on display in the Dutch War Museum in the Netherlands.

With the financial help of FWD Seagrave board member Joe Kaufmann, the museum was able to have the truck shipped directly from the Netherlands to Clintonville. The staff of the FWD Seagrave Museum will be researching this vehicle and its history so accurate information about it will be on permanent display with the artillery truck in the museum.

The FWD Seagrave Museum will begin summer hours starting May 1 with plans to be open on Tuesdays, Wednesdays, Thursdays and Saturdays from 1 to 4 p.m. Tours will be available by appointment on other days and times. A small admission fee will be charged for tours.

War dog immortalized

KING – There is a new life-sized statue of a dog at the Wisconsin Veterans Home. It's located next to the commandant's house and near the sidewalk that overlooks Rainbow Lake. It's of Brownie, a German shepherd mix from King who served in the army during World War II.

Author Kelly Nelson wrote a children's picture book titled "Brownie the War Dog: Veterans' Best Friend." She spearheaded the fundraising to memorialize the canine.

Last year was the 75th anniversary of the dog's death and she had hoped to have the sculpture in place by them but it did not work out that way. "Every dog has its day," she said.

The military did not use dogs much before WWII but a civilian group called Dogs for Defense organized a recruiting drive to commandeer dogs for the war effort. Oren Kendley, an 11-year-old boy, donated Brownie who was shipped to the Pacific to work as a guard dog.

Brownie took a bullet to the eye while serving from May 1943 to October 1944. The dog lived with a glass eye thereafter when he returned to King. Brownie lived hear the Wisconsin Veteran's Home and became an unofficial mascot to the veterans that lived there. He was friends to all.

Brownie died at the age of eight in 1949 and the dog is buried in the Central Wisconsin Veterans Memorial Cemetery. He is the only non-human buried next to veterans and Nelson believes that Brownie might be the only non-human in the world buried alongside veterans at a veteran's cemetery.

cess the internet, to have no contact with any unsupervised minor children, and to report to Portage County Justice Programs and comply with the requirements for assessment and reporting. Peterson's next court appearance is

scheduled for June 9.

In the state of Wisconsin, Possession of Child Pornography is classified as a Class D Felony. If convicted, a Class D Felony can carry a maximum of 25 years in jail and/or a maximum \$100,000 fine.

PUBLISHER'S LETTER Unto Dust...

Dear Reader,

In the final accounting, when the ledger of our days closes and the last breath escapes like a whisper into the void, what remains of us? We who once walked with purpose, loved with abandon, and dreamed beyond the confines of our mortal shellswhat becomes of all that we were?



The body, once a vessel of consciousness and desire, returns to its elemental state. Skin that felt the warmth of summer suns and the tender touch of loved ones dissolves. Bones that carried us through decades of striving and stumbling crumble into the same dust from which all life emerges. We are reduced to our most basic components, indistinguishable from the earth that receives us.

Our possessions, those objects we accumulated and cherished, outlive us for a time. Books with dog-eared pages. Photographs fading at the edges. Heirlooms passed down with stories attached. But eventually, these too deteriorate, are discarded, or lose their connection to those who once gave them meaning. The material monuments to our existence erode under time's relentless passage.

The institutions we built, the companies we labored for, the organizations we championed—these may persist beyond our individual spans, but they transform, merge, dissolve, reinvent themselves until our fingerprints upon them become unrecognizable. Even civilizations, those grand collective projects of humanity, rise and fall like tides, leaving only fragments for future archaeologists to

For in the spaces between particles of dust and grains of sand, something intangible persists. 

Trailblazing at Dayton Town Hall

Bushwhacking invasive brush


WAUPACA - Community members from the Town of Dayton started cleanup efforts on the Lyman Dayton trail, a onemile trail system built in 2016 that is located at their town hall.

Dayton Community Connection (DCC) was created two years ago as an effort for people to get out and meet community members as well as help neighbors and create social connections.

Julie Mezzoleni, a member of DCC, said the idea to restore the trail came when the group got together on New Year's Day for a party at the town hall and decided to walk the trail.

"Out of that kind of came the idea of 'what if we restored this trail and made this like a community place where people could come together and gather and walk," she said.

Mezzoleni said the trail at that time was very overgrown with invasive plants like buckthorn and honey suckle plants.



The Lyman Dayton trail, a one-mile trail system, is open again for hiking. Invasive brush was cleared and a maintenance plan is in place to keep it from growing back.

With the abundance of invasive plants the group came up with the idea of making the trail a learning experience by showing environmentally sound ways of eradicating invasive plants, as well as documenting the process of how the trail was cleaned up.

Mezzoleni said Bluestem Ecological Services was brought in first to use a forest rake to clean up the north side of the trail, the trail is split with a half mile on the north side and a half mile on the south side of the property.

With the forest rake they

were able to clear buckthorn, honey suckle and as much as the overgrowth as they could.

Mezzoleni said this is not a permanent solution, as the buckthorn and honey suckle will grow back which has led them to schedule goats, from Liberation Farmers, LLC, to come in and eat the invasive plants.

The land on the north side was split into ten segments, which was estimated to take up to 12 days for the goats to clear.

The group plans to wait to see what native plants come up without the buckthorn and honey suckle plants instead of replacing them right away.

The trail will also feature a restorative burn on part of it this fall, after which they will throw native seeds down which will allow native plants to grow with less competition from the invasive plants.

The seeds are coming from J & J Transplant and Aquatic Nursery.

There will also be a small area marked off where they intend to spray herbicide, as well as a section next to it using the black tarp method of eradicating invasive plants.

The black tarp method uses a tarp which will be secured as close to the ground as they can, which will kill anything that is underneath the tarp. The tarp stays secured for six to nine

This method, Mezzoleni said, will give you a blank slate to start fresh.

Mezzoleni said it is meant to show people how damaging herbicide is on the environment.

"We're restoring it not only for the community but also just so that we have a piece of property here that is absolutely restored," she

said. "Our hope is that they see all kinds of native butterflies and bees."

The trail is currently open for use and dogs are allowed on the trail as well.

Mezzoleni said they were able to accomplish the projects they started on the trail this year with two grants from Jim and Mary Grist Foundation of Waupaca and the James E. Dutton Foundation.

The focus in 2025 is the north side of the trail, then this fall Mezzoleni said they are going to start planning and looking for grants for the south side.

Mezzoleni said the group is hoping they are able to gather more volunteers to help with the project saying there are a number of ways that people can help, including assisting in cleanup, restorative efforts and administration.



Former Merc property to be developed

CLINTONVILLE - The city of Clintonville has been awarded a \$34,000 Vibrant Spaces Grant from the Wisconsin Economic Development Corporation (WEDC) to develop the vacant lot at 19 S. Main Street, the property where the Merc build-

ing used to stand. The development of the property will include transforming the vacant lot into a community-friendly space featuring landscaped gathering areas, an accessible walking path, event infrastructure, and seasonal flexibility to host farmers markets, concerts, and holiday celebrations. The project is being referred to as "The

Merc Project." "This is a major step forward for our community," said Caz Muske, city administrator for the city of Clintonville, in a press release. "The Merc Project will not only enhance downtown vibrancy but also support our local businesses by drawing more foot traffic and energy

to our Main Street." The space will be designed with safety, accessibility, and aesthetics in mind. Planned features include: public seating opportunities and food truck access, riprap installation and parcel grading for safety, pathways that enhance pedestrian access and connect to nearby Olen Park, and electric access for lighting and vendor opera-

The city is collaborating with Whispering Pines Landscaping, American Fence, and a concrete company, along with community partners such as Onward Clintonville and the Chamber of Commerce, to bring the project to life.

"This space is for everyone in Clintonville," said Clintonville Mayor Steve Kettenhoven, in a press release. "Whether you're here for a community event or just a quiet walk along the river, The Merc will represent our community's spirit,

resilience, and vision for the future."

Property history

The city lot was once the home to a three-story building that was most known for housing The Merc store. But the building eventually started deteriorating, and the site was cleared with support from CDBG Close and SAG funds.

Muske told the Clintonville Tribune-Gazette via email that the city originally applied for the Vibrant Spaces Grant through WECD in 2023, but the city was not selected. The city applied for the grant again in December 2024, and was selected.

NEW LONDON - Mark Grossman, treasurer for the New London Board of Education, expressed displeasure with some comments that other board members made about him during the recent WASB Board of Education Self-Evaluation the board recently took part in.

The results of the selfevaluation were shared with the board at its April 30 meeting. The comments were made anonymously.

At the meeting, New Superintendent London Scott Bleck reminded the members of the board that they completed the selfevaluation shortly after the first of the year.

"This is something the board has done annually since my time here, which has been a valuable tool to that," Heideman said. self-reflect and bring forward the status of where we are," Bleck said. "The feedback is really intended for us

as a group."

Chris Martinson, who had previously served as board president, told the board what the self-evaluation should be used for evaluation of the board, adding that it should not be used to attack other board members.

"It is easy to use the comments section to take things out on one another if we're frustrated, and I can understand that," Martinson said. "But you have to take those with a grain of salt because we all get frustrated at points where we disagree and we all say things that we regret later."

Board President John Heideman said that overall, positive board interaction scored the highest in the eight years that he has been on the board.

"I'm very happy with

Grossman agreed with Heideman, stating he scored the board the highest he has since the board has done the self-evaluation.

"But to my surprise, I was taken back by the pointed comments that were made about me," Grossman said. "So, I'm here tonight to discuss those things with you."

Grossman said one of the comments accused him of attending teachers' meetings.

"In the seven years I have been on this board, I have never, ever been in an administrative meeting with a group of teachers," Grossman said.

Grossman acknowledged that he is in the school buildings on a "somewhat regular basis." He said he's in the elementary school building to read to elementary school students. He's also in the middle school to help prepare eighth graders to attend the junior achievement job fair. A couple of years ago, Grossman said

he was at the middle school every Tuesday to have lunch with a student who needed more positive interaction with an adult male. Grossman said he's also at the high school doing different interviews with students.

"So, whoever made that comment, where that source came from, it's totally, totally false," Grossman said. "Now, if you got some good information to counteract that, I'd like to hear it right now. I'm guessing it's just hearsay.'

Grossman also brought up comments about him arguing against the majority of the board.

"A lot of these comments I think came from the conversations we've been having the last few months in

regards to the special committee," Grossman said.

"If I'm doing that, the board president's responsibility is to make me aware of that, and Chris (Martinson) and I in our conversations,(that) never came up," Grossman said. "You also have the ability, if I'm breaking a board policy, to go ahead and put me up for censorship. So, if you still believe that that's what's going on, go ahead. But I don't believe that I have broken any policies or broken any rules."

The comment that Grossman said bothered him the most was the accusation that he lied.

"That's a direct and derogatory insult on me," Grossman said. "I don't lie. I never have. I don't lie. You better have some good proof of when I've lied. I don't appreciate this at all. I've worked pretty hard

at being a part of this group. It's no secret that I'm kind of the odd man out, but I'm still here, and I'm going to continue to be here. I agree with Chris (Martinson), this is not the place for this. If you have an issue with me, call me up, we'll get together, we'll have a conversation. I'm here for one reason, to improve the education of the students in this district. It's the only reason I ran for school board seven years ago. I had no agenda. I wanted to see this district continue to improve."

After Grossman's comments, he received applause from some of the attendees at the meeting.

After Grossman's comments, Martinson said he didn't make any of the comments Grossman referred to, but that he would take the blame for some of the comments. He said he should have been quicker during meetings when he was president, to recognize infringements on the board's norms.

Board approves wage and salary increase

Staff gets 2.95% bump

NEW LONDON - The New London Board of Education approved a 2.95% wage and salary increase for the district's certified staff, support staff, and administrative staff for the 2025-26 school year, with the increases amounting to an estimated \$500,000.

The board approved the wage and salary increases when it met April 30. Board member Nate Grundy abstained from the vote for the certified staff increase.

Discussion

New London Superintendent Scott Bleck told the board that the recomincrease for all employee groups in the district. He said the recommendation was based of the board's discussion on options for wage and salary increases at its April 9 meeting, as well as the discussion at three Total Compensation Committee meetings. The 2.95% represented the consumer price index (CPI).

Leading off the discussion, Board President John Heideman said the board has a history of providing salary increases that are equal to the CPI.

Board member Chris Martinson said normally an exact salary increase proposal would be presented to the board, but this year the Total Compensation Committee was split.

"But everybody felt that, regardless of their position of what should be done, mendation was for a 2.95% that we would respect the merit-based compensation.

majority of this board on that," Martinson said.

He added that the committee approved budgeting for a 2.95% wage and salary increase. The committee could not agree on how to divide those funds up between district employees. He said two ideas were presented.

One option would be to give a 2.95% wage and salary increase across the board to all district employees. The other option was to give a flat amount to everyone who is a fulltime employee, with part-time employees receiving a percentage of that amount based on how many hours they work. The flat amount discussed was \$1,850 for the certified staff in the district.

Heideman said he'd like the board to do a more research, and in the future implement some sort of

"We need to do something along that lines to acknowledge our star performers that give 120% every day," Heideman said. "We don't have a system, let's be honest. We don't have a system to do that at this time, but I would like to see that down the road."

But for this year, Heideman said he agreed with how Joe Marquardt, SDNL business services director, presented the wage and salary increases.

Regarding hourly employees, Martinson said the board should do what it can to provide them with an hourly increase because the district is "bleeding loss of employees," especially PARA and special education employees.

Certified staff

According to the Topic staff begin at Level 1.

Summary Sheet (TSS) in the board packet, New London's certified teacher pay ranges from \$45,000-\$88,106. An increase of 2.95% would mean increases in the range of \$1,328-\$2,599, depending on the teacher's current salary.

Total working days is currently 187 days.

Support staff

According to the TSS, 34 of the 95 hourly support staff are eligible for a level increase. Employees already at level 3 would receive a \$.60 cent increase.

"The levels are set up to reward staff for retention and doesn't start a new employee at the same level as an experienced employee in the support group," it was stated in the TSS. "Unless approved by the board, all

Administrative staff

According the TSS, the district administrator reviews the recommended individual wage increases with the board, and will follow that procedure this year.

"Those specific wages are considered by the board after review by the District Administrator of each administrator's performance," it was stated in the TSS.

Budget impact

The approved wage and salary increases would amount to an estimated \$500,000 plus fringe benefits. Certified staff would receive \$312,925 plus fringe benefits, support staff would receive \$106,000 plus fringe benefits, and administrative staff would receive \$32,275 plus

shine. It will serve generations of athletes, create countless memories and stand as a source of pride for the Manawa School District. Let's celebrate this moment and all it represents."

Manawa school district baseball and softball games hosted in Manawa were historically played at Lindsay Park, as well as summer baseball, softball and Little League After the heavy rains and flood-

ing July 5, 2024 the Manawa dam was breached and flooded the sewer plant as well as the playing fields at Lindsay Park, both of which are down river from the dam. City officials were unable to

give an exact timeline for getting the fields up and running, unsure of whether they would be ready before the high school baseball and softball season started.

The Manawa school board jumped into action to make sure students would be able to host games on home turf.

"We were told by multiple contractors through the city that those fields would not be ready for play, which then mobilized the board of education to say 'hey we're go-

ing to make sure we have playing fields for our kids," Peterson said. "Baseball and softball are incredibly important to our community and the school system. We've got to figure out a way that we're going to help support that in the community."

The Manawa school board approved the measure for building the softball field on high school property Oct. 10.

Many from the community attended a meeting of the Improvements and Services Committee Nov. 14 where city officials announced that they started the bidding process for the fields at Lindsay Park.

Committee chair Ann Bonikowske announced at that meeting that the fields at Lindsay Park will be better than they have ever been, also acknowledging that the high school has opted to build their own softball field.

Bonikowske said the city would have the baseball fields done by

the time the season comes. Peterson said this really was a group effort, with people from all over the community stepping in to ensure a home field in Manawa, and to support local sports for their students.

Project details

The project is estimated to cost \$70,189, and the city must match the \$34,000 grant amount. The funds for the city's matching funds were approved in the city's 2024-26 Capital Improvement Plan (CIP) which includes various department projects that the city utilizes general obligation bonds for, Muske said.

Muske said the city hopes to start work on the project in June or July, with the exact date dependent on the schedules of the contractors doing the work. The project is expected to be completed by the end of November. While there is no definite plan

for the space, Muske said the city has worked with the Clintonville Chamber of Commerce on a number of ideas to utilize the space. Some ideas included using the space for the farmer's market, as well as additional space for existing events such as Fall Frenzy and Christmas festivities.

"Currently, the grade from the river to sidewalk on 11thStreet is so significant, we are unable to utilize the area," Muske said. "The goal of the project is to create a less aggressive grade for a versatile space to use for future opportunities such as seating, vendors, fishing, events, and much more."

Without the grant, Muske said the project could have been completed only if the city cut a project from its CIP, used general reserve funds, levied for the project within the city's operational budget, or levied for it within the capital budget with additional bonding in the city's next borrowing cycle.

"The city continues to heavily rely on grant funding and state aid for all department projects/ operations to continue to keep the operational and debt levy stable," Muske said. "The city's departments are always researching feasible grant opportunities and will continue to do so for the benefit of the community."
