

### Lady of the Lakes officially retired

WAUPACA – A sleek new catamaran-style boat made its debut on the Chain O' Lakes on May 23 and marked a new chapter for Clear Water Harbor.

The new vessel, named Ann Marie North Star, officially joins the fleet on Taylor Lake following the retirement of the Lady of the Lakes last fall.

The North Star now sails alongside the Chief Waupaca, which is celebrating its 51st summer on the Chain O'Lakes.

Waupaca is an amazing area, and we want more people to be able to experience it," said Caitlin Meighan, second-generation co-owner of Clear Water Harbor.

The Harbor's location boasts a rich nautical legacy being home to the Chain's first concessions and the area's earliest steamboat tours which began in the 1870s.

Before it became the restaurant and bar it is today, the Harbor was known simply as the dock on the lake.

Arriving visitors would disembark at the train depot, hop a trolley to the water's edge, and board steam-powered boats that carried them to their destinations.

The new boat's name reflects this legacy. "North Star" was the name of one of the Chain

O'Lakes original launch boats and a favorite of Pat Meighan, one of Clear Water Harbor's founders.

As "Ann Marie" honors co-founder Ann Marie

Meighan—also known as Mimi.

The North Star was purpose-built to address both changing tourism demands and long-standing guest feedback.

"After running the Lady for 40 years, we wanted to offer something with bet-ter visibility and flexibility," Caitlin said.

Unlike the enclosed Lady, the North Star features an open-air layout for unobstructed views of the lakes and a more immersive experience.

Built by SightSeer Marine in Hudson, Florida, the North Star was designed with versatility in Mind.

Its catamaran-style hull and twin outboard motors allow it to navigate shallow waters and stop for swims. It can also dock at private piers which will allow charter parties board the vessel easier. Unlike the Lady, which required guests to navigate stairs, the North Star features a single-level, platform-style layout, which makes it more accessible.

"There aren't many easy ways for people who don't live on the water to actually get on the water," Caitlin said. "Not everyone is com-

fortable renting and piloting their own pontoon."

The North Star holds up to 50 guests, offering both open-air seating and shaded areas beneath a canopy. It also includes a full-service bar and an onboard bathroom.

Its maiden voyage was a family affair taken just before Memorial Day weekend by the Meighan family, which included Caitlin, Ryan, Maureen, Mimi and Pat Meighan.

Final touches to the vessel are beginning this week. The North Star will run 1.5 hour narrated tours from Taylor Lake and throughout eleven lakes of the Chain.

It will also host specialty cruises including cocktail cruises, cheese and wine tours and swim excursions.

As Clear Water Harbor celebrates its 50th anniversary this summer, the launch of the North Star will help continue the long tradition of bringing people together on the water.

# Goal: zero traffic deaths by 2050

County testing safety schemes

STEVENS POINT -Portage County recently installed temporary installations around Stevens Point to test the safety of roads for drivers and pedestrians. Separated bike lanes were installed on Water Street and temporary curb extensions have been placed on campus at Fourth and Isadore Street. Installations in Plover will be added in the coming weeks, in addition to wider edge lines and optical speed bars being placed on county trunk highways in June in an attempt to get drivers to slow down if breaking the speed limit.

"Our goal is to achieve zero deaths on our roads by 2050," said Kristen Johnson, Planner for the Portage County Planning and Zoning Department. From 2017 to 2021, Portage County had a reported 7,382 crashes that included 31 fatalities. On all county roadways from 2019 to 2023, there was one reported fatality of a bicyclist. The current installations in Stevens Point are in a trial phase as the county gathers data and community feedback. The campus installa-

### Petition for wounded veteran

KING – George Smith served as a U.S. Army combat field medic in Vietnam. His missions in 1969 focused primarily on providing frontline trauma and medical care to soldiers.

Today, Smith's family is on a mission to give him the recognition they say he deserves.

Smith, 75, is a hospice patient at the Wisconsin Veterans Home at King.

Smith was seriously injured in combat while serving at LZ Sharon, a landing zone for American forces. He hunkered down in a field for hours, waiting for help. Eventually he was rescued. His injury, a severely damaged knee, required surgery. Even after surgery, the damage to Smith's repaired knee was significant enough that when his combat tour ended, he was granted service-connected benefits.

Smith's son, John, said his father's mobility remained adversely affected years after his service in Vietnam.

"You can see the scar across his knee," the younger Smith said. "He couldn't run, play baseball or basketball with me. It was because of the injury, the sacrifice he made for our country."

The family is now petitioning to have Smith awarded the Purple Heart. The military decoration honors members of the U.S. Armed Forces that were wounded or killed while serving.

"His records are incomplete," John Smith said. "His unit was overrun

"I'm passionate about my father and proud of his service to our country," the younger Smith said, visibly fighting back tears. It paves the road for them to finally receive something, an acknowledgement that they and their families deserve.'



# **New blacktop at Bucholtz Park**

CLINTONVILLE - The asphalt parking lot at Bucholtz Park will be repaved this year, replacing the parking lot at the Clintonville Community Center on the city's Capital Improvement Plan (CIP) list of projects to be completed in 2025.

The Clintonville Common Council approved the switch when it met May 13, with the cost of repaving the asphalt parking lot at Bucholtz Park not to exceed \$250,000.

When explaining the reason for the requested switch on the CIP, Ald. Stephanie Bonikowske told the council that the city has received a lot of complaints about the condition of Morning Glory Drive, which Bucholtz Park is located on. With the city trying to address the condition of Morning Glory Drive "as fast as possible," Bonikowske said it would make sense to repave the parking lot at Bucholtz Park first. If Morning Glory Drive would be repaved before Bucholtz Park's parking lot, the heavy machinery needed for the parking lot project could damage the completed work on Morning Glory Drive. 'That parking lot is in dire need of being redone," Bonikowske said. "So, we are wanting to use our resources towards that to get that done, so that when we are ready to do (repave)

# **Manawa** NEWS Shoreline restored after delay

MANAWA - The shoreline restoration project in the City of Manawa finished up last week after having to extend the deadline due to permitting issues.

The City of Manawa officials pursued and received a grant through the United States Department of Agriculture (USDA), which helped to pay for 75 percent of the repairs, with the city responsible for the additional 25 percent.



The shoreline stabilization began early spring at the Manawa dam site to ensure the n

Director Justin Mc Auly didn't know if the city had enough funds to also pave the gravel parking lot at Bucholtz Park.

"In an ideal circumstance we can find the funding to make both happen," Rose said. "Hopefully, in the very near future we can get that little section of road right in front of there, repaired as well."

Rose said the committee did consider the amount of use the Bucholtz Park parking lot receives versus

Mc Auly said the infrastructure is from the 1970s, which is considered "newer."

He said the Morning Glory Drive project, when it is done, would include curb and gutter, and possibly replacing the base of the road.

"We don't know what the base is underneath, so we could be digging that up and have to replace the base, but there's no utilities that are going to be changed," Mc Auly said.

The grant was set to expire April 25 and the project was starting to hit delays.

Josh Smith, who heads up the department of public works, said the delays were due to the permitting process through the Department of Natural Resources (DNR).

Smith said the permit process to work on the shoreline was lengthy and required multiple pieces of paperwork, saying once they submitted the documentation necessary for the permit that the DNR would ask for additional items.

## Grant agreement approved

City to receive \$211,595

NEW LONDON – The city of New London has approved a Recreational Boating Fund Agreement with the Wisconsin Department of Natural Resources (DNR) for the development of a courtesy dock, renovation of a parking area, and trail resurfacing from the Waters Supper Club to Johnny's Little Shop of Bait.

The New London Common Council approved the agreement at its May 20 meeting. The estimated cost of the project is \$423,191. The agreement with the DNR is for a 50% cost share, so the city will receive \$211,595.

To cover the city's portion of the project, the city will use around \$60,000 from the Boat Launch Funds. The remainder of the funds will come through Capital Project funds that were previously approved by the council.

According to the agreement all project activities must take place between April 8, 2025 and June 30, 2027. Any changes to the project plans must be approved by the DNR. The city is entitled to a project advance of \$105,797.

Leading off the discussion, New London Superintendent Scott Bleck said as long has he has been with the district the district has been researching improvements to Bulldog Stadium and facilities that would support bathrooms and a concessions area with running water.

The district's Facilities Committee has met several times to discuss the matter, Bleck said.

One of the reasons so much time is being spent researching the addition of bathrooms and a concession area with running water is survey results from parents and guardians in support of the idea.

Marquardt said he would like to add the project to the budget for the upcoming year, but to accomplish that, a formal plan for the project needs to be approved. He acknowledged that it is difficult to include such a project in the district's budget considering how tight the budget is each year.

Last year, Marquardt said the district received an estimate of \$525,000 for the project, which would not include the sewer laterals. Last fall another estimate was received, and again, the estimate was more than \$500,000.

After more research, Marquardt said having a formal design of the project is important when seeking competitive bids for the project. He reiterated Bleck's remarks about not seeking to build an elaborate bathroom and concessions facility.

"We're looking to provide restroom facilities to our spectators, our coaches, our kids," Marquardt said.

The district is the only school in its conference that has porta-potties and no running water at their stadium, Marquardt said.

### Next step

Board member Chris Martinson asked what the board needs to do for the next step of the process.

Marquardt said if the board would like to move forward with the next step of the project, he would like to board to indicate it is in favor of the project. He added that if the board wanted to move forward, Somerville, a company that the district works with, would put together a design phase, a bidding phase, and a construction/ administrator phase for the project. "They would put together the blueprint with the architectural, the electrical, the plumbing, the HVAC, and the finishes," Marquardt said. "That gives a general contractor or subcontractor an opportunity to say 'I want to work with the School District of New London on that project and provide a bid."" Board Vice-President

Katie Batten asked how much it would cost to have Somerville do that work.

Bleck said is would be based on a percentage of the cost of the total project.

Batten said she knows

what it is like to work in the current concession stand and said one with running water is needed. But she said she would have a hard time approving this project if it costs \$600,000.

Martinson suggested the district find a local engineering firm who could draw up a "bare-bones" project that meets codes and laws.

Board President John Heideman said the district could get the plans of other similar facilities that other districts have constructed.

"We don't need to recreate the wheel, it's there," Heideman said. "...This isn't as complicated as we're getting into."

Heideman recommended the board send the item back to the Facilities Committee to create a timeline and move the project forward.

"Have it really moving forward by July 1st," Heideman said. "I don't think we need to spend this much money, and I don't think we need it this complex. And I think we need to look at what do we need versus what do we want. The Somerville idea, I think is a want, especially in light of our budget."

Marquardt said it would help if the board would indicate a dollar amount that it is comfortable with for the project's budget. He added that the funds for the project would come from Fund 46, which comes from the long-term capital improvement fund. There is \$1.2 million in that fund.

# Monitoring: Student and Staff Wellness (Past, Current, and Future): Director of Student Services Laurie

Schmidt provided an overview of student and staff wellness opportunitie available District wide and at each building level. She highlighted four major areas: mental health and social emotional health; family resources; health screenings, and wellness presentations for students. She noted education and student services teams and they have strong working relationships. All these pieces help to prepare us for events such as the one that occurred recently. Several of the Board members noted the importance of preparedness and expressed their appreciation to Ms. Schmidt and her team on the way they handled the recent tragedy.

Administration: Wage Increase for District Employees: Director of Business Services Austin Moore advised that salaries and benefits comprise a significant portion of the District's budget, and we want to ensure we are competitive in the marketplace for high-quality employees. Therefore, he recommended a salary increase of the statutory limit of the Consumer Price Index (CPI) of 2.95% for the teacher salary matrix for the 2025-2026 school year. It was noted that not every certified staff member on the salary schedule will receive a 2.95% increase because the total allowable wage increase includes movement on the salary schedule (step and lane), with the remaining ther applied to the salary matrix for certified staff.

In addition, he recommended that Administration and District Office staff as well as all food service, maintenance custodial and educational assistant positions receive a 2.95% increase as well. The athletic/non-athletic extracurricular pay will remain at the same level for the 2025-2026 school

year, but it was noted that this will be looked at next year. 
