This is to give notice that the **City of Walterboro** has conducted an evaluation as required by **Executive Order 11988 and 11990**, in accordance with HUD regulations at 24 CFR 55.20 Subpart C Procedures for Making Determinations on Floodplain Management and Wetlands Protection. The activity is funded under Community Development Block Grant # 4-CI-21-015. The City of Walterboro proposes to use CDBG funds to do a much needed sewer improvements project, known as "Sewer Upgrade – Sub-Systems 1-East & 3", to address health and safety needs of the Ban-Croft Street, Brien Street, Del-Ray Drive, Rivers Street, Furlong Street, Bay Street, Palm Street, Birch Street, Simmons Street, Robertson Boulevard, Broadhurst Street, Towns Street, Jared Street, Cleveland Street, Madison Street, Wilkey Street, Red Comet Road, Pine Needle Road, Raleigh Street, Toya Street, Austin Drive, Jackson Street, King Street, Grayson Street, Sheldon Court and Gadsden Loop area outside of the municipal limits of Walterboro, Colleton County, SC. The project will include gravity sewer rehab (using trenchless technologies like CIPP and pipe-bursting where possible), manhole rehab and various point repairs to replace concaved pipe.

Approximately 2.77 acres of the project boundary is inside Flood Zone A. Ground disturbance may be done within the flood zone; however, the City of Walterboro has adopted a sound floodplain management program and as part of the 8-step analysis, the City will consider factors relevant to the survival and quality of the functions and values of these specific floodplains. Floodplains are an important asset to the community. These specific floodplains located within the project boundaries perform vital natural functions such as: temporary storage of floodwaters, moderation of peak flood flows, maintenance of water quality, groundwater recharge and habitat for diverse natural wildlife populations. The value of these floodplains serve as cultural resources; they also provide passive recreation in the form of green space for the community and have existed from their identification in 1983 to aid in the administration of the National Flood Insurance Act of 1968 and the Flood Disaster Protection Act of 1973.

The total amount of wetlands in the project area is 29.18 acres. Wetland #1 is 6.71 acres located on Gadsden Loop and Raleigh Street where sewer rehab is proposed. The pipeline that requires repair in Wetland #1 is located in the roadway and extends just off of the pavement. Wetland #2 is 17.78 acres, Wetland #3 is 3.46 acres, Wetland #4 is .46 acres, and Wetland #5 is 2.43 acres but construction is not planned to occur in any of these areas. Wetlands regulate water flow, reducing flood peaks, provide habitat for plants and animals, serve as breeding grounds and nesting sites, and improve water quality by retaining or transforming excess nutrients and by trapping sediment and heavy metals.

City of Walterboro has considered the following alternatives and mitigation measures to be taken to minimize adverse impacts and to restore and preserve natural and beneficial values:

- (i) The reason for the proposed work to be performed is to address inflow and infiltration in the City's existing wastewater system in this area.
- (ii) The proposed work is to use "no-dig" technology for the sewer lines. The other alternatives are for the city to open-cut and replace the existing pipe but this is more expensive and involves ground disturbance, or to leave the pipe in its current state to worsen and cause problems to the citizens it serves, which is not a viable option.
- (iii) Army Corps of Engineers, General Engineering Branch mitigation measures stated: Since portions of the project may be subjected to flood hazards, City of Walterboro has considered the following alternatives and mitigation measures to be taken to minimize adverse impacts and to restore and preserve natural and beneficial values and functions: Project design should include provisions to (a) assure that flood hazards will not be created by flow obstructions or debris collection (silt fences), (b) protect the pipes from high velocity flow at stream crossings, (c) prevent water pollution due to flooded sewer systems, and (d) flood proof any electrical/mechanical equipment that would be damaged by flood waters. If the above referenced project requires any alteration to flood plains (i.e., discharging dredged or filled material or mechanized land clearing activities), a Department of the Army permit will be required. For the wetlands, sewer improvements are proposed to be upgraded via trenchless technology and best management practices for this method will be followed which include boring and drilling of sufficient depth below the wetland and entry and exit points are far enough from the wetland to avoid adverse impacts to the area, siting all areas outside of wetland areas, avoiding construction during sensitive times of the year that will impact fish spawning and bird nesting habitats, maintaining site specific erosion control measures, restoring the area to preconstruction conditions, and planting or re-establishing vegetation buffers in coordination with an invasive species control plan. However, if it is discovered that this method is not suitable and replacement of the pipe is required in any wetland areas, the pipe will comply with all applicable Corps of Engineers permitting requirements and ensure the contractor follows the appropriate measures during construction to ensure the wetlands are protected and/or restored as required by the Corps.

City of Walterboro has reevaluated the alternatives to working in the **floodplains/wetlands** and has determined that it has no practicable alternative. Environmental files that document compliance with steps 3 through 6 of **Executive Order 11988 and/or 11990**, are available for public inspection, review and copying upon request at the times and location delineated in the last paragraph of this notice for receipt of comments.

There are three primary purposes for this notice. First, people who may be affected by activities in **floodplains/wetlands** and those who have an interest in the protection of the natural environment should be given an opportunity to express their concerns and provide information about these areas. Second, an adequate public notice program can be an important public educational tool. The dissemination of information and request for public comment about **floodplains/wetlands** can facilitate and enhance Federal efforts to reduce the risks and impacts associated with the occupancy and modification of these special areas. Third, as a matter of fairness, when the Federal government determines it will participate in actions taking place in **floodplains/wetlands**, it must inform those who may be put at greater or continued risk.
