If at the close of filing a party primary is necessary to determine the party nominee (multiple candidates file for one party's nomination), a primary will be held on Tuesday, March 8, 2022. Any necessary runoff will be held on Tuesday, March 22, 2022. Any person wishing to vote in these primaries and runoffs must be registered by Sunday, February 6, 2022. Voter registration by mail applications will be accepted if postmarked by Monday, February 7. The special election for this office will be held on May 17, 2022.
